EMDR Basic Therapy Training

Course Trainer: Rhonda Kamai-Kekela, LCSW

EMDR International Association Trainer and Approved Consultant

This is the complete EMDR Therapy Training approved by EMDRIA, formerly known as Level I and Level II. Participants will learn the EMDR psychotherapy approach, the basic eight-phase EMDR protocol, the Adaptive Information Processing Model, and how to incorporate EMDR into your practice. This course will consist of didactic presentations, demonstrations, supervised practicum, and case consultations. Participants must attend the full training and five 2-hour consultation groups to receive a certificate of completion in EMDR Therapy. Approval of partial programs will not be granted.

Required reading: Eye Movement Desensitization and Reprocessing: Basic principles, protocols, and procedures, third edition, by Francine Shapiro, PhD, EMDR Therapy originator.

Qualifications for Attendance: A clinical background is essential for the effective application of EMDR. Attendance at the workshop is limited to mental health professionals who, at a minimum, are enrolled in the practicum phase of a master's degree program. This course is appropriate for licensed and pre-licensed mental health professionals including Psychologists, Marriage and Family Therapists, Clinical Social Workers and Professional Clinical Counselors.

Training Information: This is a 2 Part training consisting of 3 days each Part- 6 days total.

Dates:

Part 1: December 16-18, 2021, Vernal, Utah. **Part 2:** Apr. 25-27, 2022, Kea'au, Hawaii.

Training Location: Exact address in Vernal, UT and Kea'au, HI will be emailed to you.

Payment: Payment is required to reserve your seat.

After you have registered and submitted payment, you will receive a pre-training email containing the address and directions to the training location if it is not specified on the website.

Training Schedule: Trainings start promptly at 8:30 am.

Please arrive before the scheduled start time to sign in and find a seat.

Day's 1 & 2: 8:30 am - 5:00 pm.

Day 3: 8:30 am- 4:00 pm.

Consultation: Consultation with EMDR 808 Pacific is included in the cost of the training. Each attendee **must attend 10-hours of group** consultations in addition, to the 6 training sessions. You will be provided the consultation schedule assigned to your training group. You should make every effort to attend the assigned dates. Tarena will send out Zoom links the day before the consultation.

Combination Utah & Hawaii Cost: \$1650 (\$100 discount for pre-licensed and non-profit).
