NON BIO HAD HIS RIGHTS FULLY SEVERED

Robert Foster Christner-AKA RAY came up with an FBI HIT in 2005 when at the time the "Couple" were married went to China to adopt Claire - discovered he had been living under an illegally assumed last name.

Another FBI Hit for furnishing alcohol to a minor in a park in Scottsdale Az. 1986

Documented with US Homeland Security letter 2 charges Contributed to the delinquency of a minor & furnishing alcohol to a minor

Married before living under an illegal name from 1982 - 2006 Mrs. Pigman at that time had to go through a legal name change (federal form) just to get a visa to adopt Claire.

Mrs. Pigman confronted him- he claimed he changed Maricopa Arizona
Adopted 2007 started process of Nolan TuanTu Nguyen finally adopted him January 2008, he was 6 months old. At this point Mrs. Pigman begins noticing very disturbing behaviors of Mr. Christner. Mr. Christner was a teacher at Forest Grove School district (the highschool) Mrs. Pigman had no idea if he was fired or quit- but suddenly Mr. Christner tells his then wife we have to move. They lost their home in 2010 with three children - Three potential buyers and he never returned calls. The home was lost to foreclosure. The "family" moved to a house in Clackamas Oregon and this is when Mrs. Pigman began discovering horrific abuse. Snuggling in his underwear with Nolan and acting more and more disturbing with the boy. Roughing Nolan around, inappropriate touch of Nolan, the Australian shepard was suddenly for no reason found dead, with blood coming out of nose. The children were crying he acted indifferent. In 2012 the children saw mom suffer Massive cecal volvulus and Mr. Christner let Mrs. Pigman sit there and suffer for 48 hours. Finally threw her in a van and never got her medical attention. Mr. Christner went to a diner and ate lunch while Mrs. Pigman suffered. He finally drove to Portland, his teacher assistant named Sierra English was house sitting and told Mr. Christner to get Mrs. Pigman to emergency care and he finally agreed to. That evening Mrs. Pigman had emergency surgery and they took 2 ft of her colon. Sierra English is a very pertinent character witness and a witness to the abuse mother and children suffered in his presence.

In 2013 the family lost this rental house also due to lack of payment because Mr. Christner barely worked. The family moved to an apartment and Mr. Christner was seen frolics with little boys- he had a fixation with little boys. Mr. Christner asked the housing managers where one little boy lived, they refused to tell him. Nolan began reporting sexual abuse to Mom, May of 2014 to Mrs. Pigman. Claire began telling Mrs. Pigman of rough and aggressive behavior of grabbing Nolan by the neck and throwing him into the bucket seat of his truck. Tying his shoelaces so tight it would hurt Nolan, Slip his hands down Nolars shorts and take the draw string within the shorts and tie them so tight it would make a band around his waist. Nolan kept asking mom Mrs. Pigman to divorce "Robbie"

Nolan was fearful of even doctors to examine him, or do tests for urinary tract infections. Afraid of dentists all due to his own admittance of anal and oral abuse by Robbie. Not until Robbie Mr. Christner was thrown out of the home did Nolan tell all the horrific details to mom Mrs. Pigman. Nolan divulged to Mrs. Pigman and the primary care doctor Dr. Timothy Lan that he spit out white stuff after Robbie did the unthinkable.

Before he was thrown out of the home he slapped Nolan across the face with a back hand becoming rougher and rougher and more aggressive toward this little boy. His main target was Nolan. However, he did abuse Claire.

Thankfully Mrs. Pigman has full custody of the adopted children and Mr. Christner's rights to them have been terminated. **(SEE ATTACHED)** However, their biological daughter was in his full custody and is endangered everyday by this man. She is now 20. The estranged couple was given joint custody despite his horrific background. He was court ordered to participate in a 2nd parental assessment study August 2015 to see if he was safe and he never did the assessment yet he had unfettered access to this child. He never gave Mrs. Pigman her custodial time that was Ordered. The court demanded he follow the order and he never did. He

was never held in contempt, he was never arrested for not following the order and the years passed while this child grew up without her loving mother. Mom would show up at the highschool with gifts (he was a teacher there) The Judge never enforced the order even though he violated the order repeatedly. The State of Oregon DOJ crime victims compensation unit (Attorney General Ellen Rosenblum) claims acknowledging that Mrs. Pigman and children are victims of a compensable crime. Attorney General Ellen Rosenblum is completely ignorant of the danger presented to children in her state, as Mr. Christner is a school teacher around children all the time. A fully operational pre-school is right next to his auto shop where he is an auto shop teacher. The children take child development classes.

Mrs. Pigman also reported to "Teachers standards and practices" as well as "child unit division" and they never did revoke his license. The state licensing for the preschoolers never returned Mrs. Pigman's calls, instead they covered it all up and threatened Mrs. Pigman. Mrs. Pigman also reported to Senator Shemia Fagan. Sen. Fagan's legislative aide actually went to Mrs. Pigman's home in 2015 to obtain a court ordered immediate danger order and the abuse reports. Despite obtaining the highest protection order and abuse reports they failed this family by completely ignoring and dismissing it. Mrs. Pigman also reported him to Sara Gesler (in Time Magazine for ME 2) and also ignored this family's desperate request to protect their daughter & sister as well as countless children.

This is the most irresponsible judicial miscarriage of justice I have ever seen as a National Advocate. I have personally spoken with the children. They are well cared for and educated and given every opportunity in life. However, they had been denied their legal civil rights to a US Birth certificate, it's been 5 years. These children are relatively well adjusted despite all the trauma and abuse, I attribute this to their wonderful mother. As a well-known and very public broadcaster we have a moral and legal obligation to protect ALL CHILDREN especially the ones in Mr. Christner's care.
