To whom it may concern:

Good Morning, I am Russell Tinsley who has been civilly committed at the New Jersey's prison punishing me wrongfully, in the STU-Special Treatment Unit, at Avenel.

I am reaching out to you regarding Senators Morrissey and Patrick Hope, both Democrats and their bill to abolish civil commitment for sex offenders. I believe to further see the merit behind abolishing civil commitment, I am proposing my life story to be heard in the Senate Judiciary, and for the committee to vote as well as to send it to the State's Crime Commission in order to study the best way to go about rescinding these authorities and how best to treat those with sexually-related convictions.

I would like to share my life story for legislation that would end the unfair law on civil commitment, because although I have been civilly committed in New Jersey, I was never charged, convicted nor sentenced for a sex offense in the state of New Jersey, which is required for their state's authority to civilly commit me.

I have been in New Jersey's prison facility "STU" now for (11) eleven years. It took me my first (3) years to get the initial civil commitment hearing, without allowing me to retained my own expert psychologist who could had testified that I did not meet the criteria to be eligible for commitment as a sexually violent predator. Also, I haven't had a review in (11) plus years. Other words, I never had my first annual review (yearly) hearing to date, so I strongly know that this law is very unfair, and I want to go forward.

I have been locked away in New Jersey since 2010, for a 2005 sex offense in Philadelphia, Pennsylvania in which I took a plea deal for a crime I did not do in order to get probation, because I needed to get out of jail to help my dying mother, as well as to make my connection with the Pennsylvania's system and my Association with the J.J. Peters Institution.

During my civil commitment I have been denied credit for the work I have done in my treatment, as well as being placed on treatment refusal status for a book I'd published entitled "Civilly Committed". Every time completions for treatment assignment are done, if any I was told "you've passed, but you still have to repeat treatment assignments" over, over and over again.

Every time I completed an treatment assignment, the STU's staff are never satisfied, and only gives a negative response to sabotage my progress, to keeping me locked away for life and in a very restricted section of the facility and where most of my legal, treatment, personal, religious, and business property are either missing or broken up by the STU's prison correctional officers when given back to me.

I know my life story will support legislation about keeping me committed, because of my past crimes.

I strongly believe that if all the people would really know what's going on behind these laws and walls to civil commitment of sex offenders, they would know and believe that this law and scheme of keeping someone locked away for life need to be changed and speak out about it. Maybe my life story can help getting something to be done, and the public would learn what is really happening. Especially, when murders, terrorists and many other violent persons who commit a violent assault serve their sentence and then goes free. However, not sex offenders who have to serve his time and then are committed for the rest of their life.

The people need to know the cost to keep these offenders committed. If they knew this, they would be shocked to learn, that the average cost to maintain a sex offender in a commitment facility is about \$180,000 per year, per offender. There are about 4200 offenders being committed in the United States of America, which is a total of \$750,000,000.00 per year. I am sure that this money could be used for something much better than civil commitment which doesn't work.
