2021 Tax Collector Education Committee Report

The Education Committee is charged with scheduling programs of timely topics of interest for the tax collectors to be presented at the New Collector's Workshop, Spring Workshops and the Annual Education Conference. This year's committee was set up with sub committees. One for each of the education components. With COVID 19 this year we were tasked with providing education virtually.

The "New Collector's Workshop" were broken out over four virtual sessions, March 22, 24, 26 & 29. The intent was to record all sessions, but with the learning curve, some of the first sessions did not record. All sessions were very well attended with record numbers in attendance. The sub-committee was led by Diane Trippett from Merrimack, with the assistance from Daphne Woos, Brentwood and Brenda Adams, Manchester.

Friday will feature Association Legal Counsel Bernie Campbell and Demers & Prasol (virtually), who will provide legislative and court case updates on items that affect tax collectors. In addition, Attorney Campbell will also provide an in-depth discussion about the right to know in regards to delinquent tax requests. Also, equally important is to continue providing this information on session evaluation forms.

Committee members go "above and beyond" their daily routines when agreeing to serve on a committee and take on additional tasks and this year was no exception.
