3. Discussion of Zoning and Subdivision Regulations Revisions: Pate Done and Carlotta Brown

Mrs. Pat Done spoke to council about the current Subdivisions Ordinance and that the only changes that will be made is to bring it in line with state standards. One of the other changes will be on green areas within subdivisions. The update will set a standard of the size and use of green areas. It also authorized the MPC Director to approve minor plats on changes to lot lines. The new Subdivisions Ordinance will also bring the Town more in line with the Parish regulations. It also addresses that all fees must be paid prior to approval of any masterplan final approval. This will ensure that all developers are following the current standards that were already in place.
