

2023 has begun and our calendar reveals a delightful mix of day trips, journeys and events.


If you missed the January meeting make note of these three items:



Panama City Adventure (after the Costa Rica Exchange) – Shirley Schultz and Sue Palmer

After the Alajuela FF Farewell Party, Shirley and I headed for our last week of adventure to see the Panama Canal. February 28, 2013 at 11 pm, we boarded the Tica Bus in San Jose'. The bus ride was definitely an experience – long trip (14 hours)! The bus did have its advantages; a bus attendant (similar to an airline attendant) was on the bus to serve cold drinks; hot tea or coffee; cookies and 2 meals. We stopped at a small town by a MacDonald's; I saw a guy carrying a big box heading towards our bus. Our attendant brought the box on board and served each passenger a **BIG MAC** and orange pop. (I can't remember the last time I had a Big Mac). We were also served a breakfast which consisted of a sandwich; cookies; chips. The driving time on the Panama Highway was approximately 10 hours.

The remainder of the 4 hours was spent in customs when crossing from Costa Rica to Panama City. It was a long process with several hours of showing passports and handling your luggage for a security check. We arrived at the border at 4:30 am and waited for the Customs Office to open at 6 or 6:30 am (Costa Rica time)? Along the highway we were stopped several times by the border patrol coming on board and checking passports. Shirley and I were the only Americans on the bus, we were pleasantly surprised by how respectful they were to Shirley. The other passengers would let Shirley and I go first in line to the custom offices.

We arrived in Panama City on March 1, 2013 at 3 pm; we stayed in a good location downtown in a 2 bedroom apartment.

The 6 days in Panama included a fascinating tour of the Panama Canal on a local tour bus. We boarded the Pacific Queen Tour boat; we were able see the entire process of how the Canal operates, as we traveled through the locks and entered the Pacific Ocean. It took 10 years to complete the canal and it was in full operation by 1914. Today it still operates on the same system since it's completion in 1914. It's a marvel and all Americans should be proud of the job accomplished by the US.

Panama Canal employs over 10,000 employees and its 76% of the Panama City's revenue.

We toured the museum and saw a presentation on the history of the canal. Each day we took the "On &Off" City Tour bus, so we could enjoy seeing the city of Panama is a BIG CITY with skyscrapers and exclusive shopping centers. Panama City is a very prosperous and beautiful city.

March 6, we boarded the Tica Bus to return to Costa Rica (another 14 hours of fun and adventure)! We returned to our US home on March 8 – glad to be home but savoring all the memories.




