1. PLEASE FIND ENCLOSED A VENDOR APPLICATION FORM. THE SOCIETY NEEDS TO RECEIVE YOUR APPLICATION ASAP AS SPOTS FILL UP QUICKLY. BY SENDING YOUR APPLICATION IT **DOES NOT GUARANTEE** YOUR VENDOR SPACE, UNTIL A DIRECTOR HAS BEEN IN CONTACT WITH YOU TO FINALIZE YOUR APPLICATION.
2. SETUP TIME IS FRIDAY SEPT 24 2021 FROM 5PM-7PM, OR SATURDAY SEPTEMBER 25 2021 FROM 7AM – 9:30AM. **FAIR OPENS AT 10AM**
3. YOUR VENDOR SPACE ENTITLES YOU TO THE AMOUNT OF SPACE RESERVED AS WELL AS 2 VENDOR PASSES. ONLY 1 VEHICLE PER VENDOR SPACE IS ALLOWED AS WE HAVE LIMITED PARKING SPACE.
4. THE FAIR CLOSSES AT 7PM SAT SEPT 25 2021. NO ONE WILL BREAK DOWN DISPLAYS BEFORE 7PM. IF YOU SELL OUT, YOU ARE STILL REQUIRED TO STAY UNTIL 7PM.
5. HUNTSVILLE DISTRICT AGRICULTURAL SOCIETY WILL NOT ASSUME RESPONSIBILITY FOR STOLEN OR DAMAGED GOODS.
6. VENDORS ARE RESPONSIBLE FOR THEIR OWN LIABILITY INSURANCE. PLEASE INCLUDE A COPY WITH YOUR APPLICATION.
7. ALL FOOD VENDORS MUST HAVE A CERTIFICATE FROM THE HEALTH UNIT.
8. **VENDOR SPACE AND LOCATION WILL BE ALLOTTED TO YOU BY THE VENDOR CHAIRPERSON. NO ONE SHALL CHOOSE THEIR OWN SPOTS.**
9. ALL FORMS ARE TO BE SENT TO THE ABOVE EMAIL ADDRESS
10. FULL PAYMENT MUST BE SENT WITH YOUR APPLICATION TO SECURE YOUR SPACE.
