

<u>DIRECTIONS</u> – to Ox Creek Farm, LLC – 5275 Parrish St Ext Canandiagua, NY About 15 miles from NYS I-90 Thruway exit 44 (Canandiagua) Travel South on Rt 332 about 9.3 miles. Turn Right onto State Route 5 & 20 about 1.5 miles. Turn Left onto Parrish Street Extension.

You want to go down the HORSE ARENA driveway NOT the house. – PLEASE GO SLOW – FARM DOGS ARE LOOSE ON THE PROPERTY. Travel to the left of the arena and just past the storage trailer pull into the field, on the left and park in small field.
