# **Enrollment Process**

If you are interested in Therapeutic Day Treatment (TDT) services for your child, please complete the following process:

First, talk with your child's school counselor about appropriateness of the service for your child and space availability.

Call 540 213-7584 to be screened for program eligibility. TDT is a Medicaid funded program, so your child must meet criteria to be eligible for services. Criteria may include:

- Having a mental health diagnosis
- Being at risk for a mental health hospitalization or out-of-home placement.
- Repeated interventions by mental health, social services or the judicial system.
- Inability to recognize personal danger or inappropriate behaviors.

If your child meets criteria, you'll be contacted to schedule an intake for TDT. The intake is conducted at the school and takes 1-2 hours.

# About Therapeutic Day Treatment

Therapeutic Day Treatment (TDT) provides intensive mental health services to students in the school environment. Children in the program have social, emotional, or behavioral problems that interfere with their ability to function at school, home, and in the community. Our goal is to help your child develop skills to effectively express emotions, manage behaviors, and get along with others so he or she can remain in their school and community. This is done through therapeutic activities designed to build on your child's strengths while enhancing self-esteem and teaching new skills.



### **Services**

TDT services occur in the school environment and include the following:

- Classroom support
- Individual and Group Sessions
- Crisis Intervention
- Family/Parent Involvement

#### **Payment**

Therapeutic Day Treatment services are typically paid for by Medicaid insurance. Once a child is determined to be eligible for services based on criteria established by Medicaid, services will be billed to Medicaid by Valley Community Services Board.
