Minors Driver Education Course Consists of Three Phases (Instruction Permit required to begin Phase 2 & 3);

- * Phase 1: Student must successfully complete 30 hours of classroom instructions.
- * Phase 2: Student must successfully complete 6 hours of Behind The Wheels (BTW) Instruction.
- * Phase 3: 50 hours supervised driving (40 hours daytime/ 10 hours night): Student's Parent/Legal Guardian must Notarize the affidavit verifying the student has at least 50 hours of driving with a licensed driver 21+ years of age. The completed Notarized Affidavit must be submitted to the BTW instructor in exchange for the BTW certificate of completion. Affidavit will be retained by instructor.

- * \$100.00 deposit must accompany application to reserve a seat for the classroom session; deposit will be applied to fee. Full payment must be received by the first day of selected course. - * Payment maybe made by Cash, credit/debit card through PayPal, or check payable to EZ1 Driving, LLC. Returned checks will incur a \$30 service fee.
- * No refund if cancellation is received less than 5 business days prior to the meeting of the first class
- * BTW lessons require a 24 hour notice of cancellation or a \$50.00 fee will be assessed.
- * Students must wear dry clothing (no swimsuits) and footwear.
- * Family members/friends will not be allowed to remain on site while class is in session.
- * No smoking, using profanity, disrupting class and fighting with other students and/or instructors.
- * Students must have their Instruction Permit in person during BTW session.
- * Cell phone use will NOT be allowed when class is in session. If there is an emergency while your child is in session, please call the instructor. This will help to ensure the safety of your child, other students and the instructor.
- * Failure to follow these rules may result in the following disciplinary action:
 - > Dismissal from class (parent/guardian will be notified immediately)
 - > Forfeiture of class time (student will have to retake class)
 - > Expulsion (no retakes or refund will be given to an expelled student)
