## Admissions in the STAR

 The Consultant in emergency medicine and clinical programme director for unscheduled care Hywel Dda Health Board - writes:

"For too long the general public of Llanelli have had the mistaken perception that they may lose their local accident and emergency department when in fact Prince Philip Hospital has not possessed such a unit for a number of years ...... Patients would continue to be seen at Prince Philip if the unit was renamed urgent care centre ...We risk providing an out of date model that doesn't provide patients with the best and safest emergency care."

- I would like him to explain why it is better for the people of Llanelli to have the Emergency Service provision in Glangwili rather than Prince Philip? Why would that be outdated?
- He asks us to read the health board's discussion document. I would ask you to as
  well because I have read it and it is an uncosted, unproven and non specific
  document which talks in vague terms of a utopian impractical solution based
  around clinicians and not delivering a viable or realistic service to the public.

## Admissions in the STAR

Next to his letter of smug self righteousness there is one from a 78 year old man who took his wife into the "A.& E." at Prince Philip at 09.00 where she was seen by the excellent staff and tests were carried out....but her pain was not relieved although they tried but because we don't have a Urology Department at Llanelli anymore ......

He was told to take his wife to Glangwili A & E with the test results from PPH (there was no ambulance available) and they got there at 17.00.

At 18.30 she still hadn't been seen (remember his wife has been in agony all this time) and eventually was seen at 20.00.

The consultant left to check with colleagues and the gentleman returned home at 23.00 so he could get some rest leaving his wife in Glangwili.

At 01.00 the following morning his wife was told there was a bed available but the consultant couldn't do any thing further apart from give her pain killers.

At 02.00 his wife was discharged and although she asked if her husband could pick her up at 07.00 she was told to ring him at 02,30 to collect her.


So this 78 year old had to drive to Glangwili at 02.30 in the morning in the ice...

## What have they done?

From a report for Rochdale Council in 2007.....

...... under these proposals, Rochdale Infirmary will become a new 'locality hospital'. It will have an Urgent Care Centre (UCC) in place of A&E; beds for planned surgery and selected patients with medical conditions, outpatient clinics and day surgery, a full range of diagnostic procedures, rehabilitation services and tests and a cardiology 'centre of excellence'. These hospital based services are to be complemented in Rochdale with – and the preferred option depends upon......

...... a 'full range of health services', including the management of long-term conditions, intermediate care and rehabilitation, to be provided in the community, specifically in ten new community-based health centres to be built under the LIFT initiative.



## What have they done?

From a report for Rochdale Council in 2007.....

 Under the proposals, Rochdale residents will be able to access acute medicine and A&E services at any of the three other hospitals within the Trust, the nearest of which is Fairfield Hospital, Bury, and emergency surgery at North Manchester General and Royal Oldham Hospital

Rochdale's A&E unit will close in 10 days and the hospital will stop

Paramedics have been taking people with serious illness and injuries to neighbouring hospitals at night-time since August after hospital bosses failed to recruit enough emergency doctors.

On April 4 the Infirmary's walk-in centre will also close. The units will be replaced by an Urgent Care Centre, open round the clock, providing 85 per cent of treatment currently carried out in A&E for people who have a minor injury or illness.

## Two patients died after waiting in ambulance outside 'full' Oldham hospital unit

Two patients died after being left waiting in ambulances outside an overstretched hospital.

The patients, believed to have been in their 80s, couldn't get into the Royal Oldham Hospital for seven and 20 minutes respectively.

They were assessed by ambulance crews as 'very sick' and were both suspected of having suffered heart attacks.

The A&E department was so busy that all but the most urgent cases were being sent to other hospitals at the time. All five resuscitation beds at Oldham were full.



## CIHS – Raising the Profile

- 25 % of the Committee attended Carmarthen protest at Hywel Dda Board Meeting arranged by Labour with our MP in November
- Sat in on the Hywel Dda Board Meeting
- Received Letter from Chris Martin of Hywel Dda asking to meet with us to give our views of the proposals, which we accepted
- Written off for and received back many Freedom of Information requests
- Interviews with the STAR
- 8 Interviews with BBC, BBC Cymru, Radio Cymru, ITV
- 33% of Committee attended the Plaid Cymru organised demonstration
- Presentation to Women's guilds. Age Concern etc...
- Meetings with Llanelli Town and Rural Councils who have given support
- Gave presentation to Hywel Dda Board Members (Mr Purt did not attend)
- Distributed the Presentation to all local political party leaders including local MP, AMs, County Councillors, Llanelli Town and Rural Councils, the First Minister, the WAG Health Minister etc. and posted it on the Web Site (No politician can say that they are unaware of the feelings of the people of Llanelli)
- Created a Petition checked by clinicians and supported by the Town and Rural Council and the STAR (who put it online)
- 80% of Committee Members marched with Llanelli Against the Hospital Cuts
- Presented the Hywel Dda presentation to the Rural Council last Tuesday
- We were at Hywel Dda consultations last Tuesday (which were a complete shambles)

## Llanelli is an Urban Community

- The Largest Town in the Hywell Dda Area.
- Llanelli Town = 60,000 people in the Town within 15 minutes of Prince Philip Hospital
- Catchment of 100,000 people within 16 25 minutes of PPH in Carmarthenshire.
- Total Catchment of 250,000 within 25 minutes of PPH (Swansea County) Cross charge services options.
- An Expanding Town, A Permanent Market, 2 Separate Retail Parks, Numerous Other Shops, Heavy Industry, A Brewery, Farms, Motorway, Chemical Plant, Steel Plant, Copious Goods Trains, A Number of Business Parks, Leisure centre, Swimming Pools, Parks, Beaches, Dock, Fisheries, Extreme Sports, Many Restaurants, an Airfield, Leisure Industry, Sea Side, Swiftly Increasing Population, Many Developments, Construction, 15,000 seater Rugby Stadium, Athletics Track, Football Park, Infrastructure Expansion, Many Hotels, Country Park, Schools, Colleges, Care Homes, Tourism, etc.......
- Also fluctuating increases in population due to commuters and shoppers coming into Llanelli



## An Urgent Care Centre is the wrong option for Llanelli.

- Replacing the A&E
- Will treat minor breaks, sprains, cuts, scalds, abdominal pains, breathing difficulties, mild asthma attacks, chest infections, back pain. (Couldn't this be done by Specialist Nurses?)
- More Serious injuries and major trauma requiring specialists will go to the nearest
   A&E (Glangwilli) so the most ill are the farthest away from hospital treatment.
- The UCC will NOT receive life threatening cases, or serious cases, including major trauma and injuries, major fractures (hip), chest pains, strokes, heart attacks, unconscious patients.
