Arizona Revised Statutes

ARS 15-321. Organization: Election of Officers of the Board; Meetings; Execution of Warrants; Exemption



Arizona Revised Statute 15-321

- A. For the purpose of organization of the governing board, the board shall meet at the most convenient public facility in the school district. If a public facility is not available within the district, the governing board may meet at any available public facility that is convenient to all governing board members, regardless of the county or school district in which the facility is located. The governing board shall meet between January 1 and January 15 next following the election.
- B. At the organization meeting the governing board shall elect from among the membership of the board a president.
- C. For the purposes of regular meetings of the governing board, the board shall meet at the most convenient public facility in the school district. If a public facility is not available within the district, the governing board may meet at any available public facility that is convenient to all governing board members, regardless of the county or school district in which the facility is located.
- D. The board shall prescribe rules for its own government. It shall hold a regular meeting at least once each month during the regular school year and may hold other meetings as often as called. If action has been taken and documents approved at a meeting, they may be signed subsequently by individual board members.



Arizona Revised Statute 15-321

- E. Business shall be conducted at regular or special meetings. Notice of a special meeting, and of the hour for a regular meeting if no hour is fixed by a rule of the board, shall be delivered personally or by telephone.
- F. Notwithstanding section 1-216, if there is a vacancy or vacancies on the governing board, a majority of the remaining members of the governing board constitute a quorum for the transaction of business, except that a single member of the governing board does not constitute a quorum.
- G. An order on a county school superintendent for a salary or other expense shall be signed by the governing board. An order for salary or other expense may be signed between board meetings if a resolution to that effect has been passed prior to the signing at a regular or special meeting of the governing board and the order is ratified by the board at the next regular or special meeting of the governing board.
- H. This section does not apply to county school superintendents in the conduct of an accommodation school.

Important to note in law: There is a difference between *SHALL* and *MAY*.



Arizona Revised Statutes

Let's look at a few different school districts policies based on ARS 15-321 (d).

D. The board shall prescribe rules for its own government. It shall hold a regular meeting at least once each month during the regular school year and may hold other meetings as often as called. If action has been taken and documents approved at a meeting, they may be signed subsequently by individual board members.

- A motion to adjourn is in order at any time. Such a motion shall require a majority vote. No discussion is in order.
- A motion to table is in order at any time. Such a motion is limited to being considered only once on any given agenda item. No discussion is in order.
- Items may be presented at a Board meeting by the public for Board consideration in accordance with policy BDDC.
- No motion, resolution, or other form of action or procedure proposed for the first time at any regular meeting shall be acted upon until a subsequent meeting, if one member requests its postponement.
- In a Board-declared emergency, policies may be enacted, repealed, or amended at any regular or special meeting by the unanimous vote of the full Board without previous notice having been given.

RECOMMENDATION:

It is recommended that the Governing Board approve and adopt the revisions to Policy BEDD, Rules of Order.

BACKGROUND:

Issue: The current wording of Policy BEDD, which governs the Board's conduct, is limited in scope. The Board has consistently sought methods for making meetings more efficient. Enabling the President to enact additional rules of order to accomplish this goal is necessary to achieve this goal. Standard rules of order can then be used, such as those outlined in Robert's Rules of Order Newly Revised (12th Edn. 2020). For example, the President could limit Board members to speaking once on any item, preventing drawn out conversations and repetitive questioning of staff.

Solution: The proposed revisions to Policy BEDD provide the President the opportunity to implement additional rules order to support the orderly and efficient operation of the meeting.

AZ Coalition 2.51 Meetings – Regular, Special, Study Session

Adopted: (date of adoption)

Definitions: "Meeting" means the gathering, in person or through technological devices, of a quorum of members of a public body to discuss, propose or take legal action, including any deliberations with respect to such action that has been properly noticed, pursuant to Arizona Revised Statutes. A meeting includes a one-way electronic communication by one member of a public body that is sent to a quorum of the members of a public body and that proposes legal action. A meeting also includes an exchange of electronic communications among a quorum of the members of a public body that involves a discussion, deliberation or the taking of legal action by the public body concerning a matter likely to come before the public body for action.

Policy Objectives: It is the intent of the Board to conduct all business of the District in the District, in public and with proper notice to maximize transparency and public participation.

The Coalition Policy



- A. The Board shall conduct all business at official meetings of the Board. These may be either regular meetings, special meetings, or study sessions, defined as follows:
 - 1) Regular meeting the usual official legal-action meeting, scheduled and held regularly.
 - 2) Special meeting an official legal-action meeting called between scheduled regular meetings to consider only specifically identified topics.
 - 3) Study Session an official non-action meeting called between scheduled regular meetings to study identified topics.
- B. The Board shall hold a regular meeting at least once each month during the regular school year and may hold other meetings as often as called.
- C. Every meeting of the Board shall be open to the public except for an executive session that is held in accordance with state law.
- D. Notice of all Governing Board meetings, regular and special, shall be posted in compliance with the requirements prescribed by A.R.S. 38-431.02.

The Coalition Policy



- E. Votes on all motions and resolutions shall be ayes, nays, abstentions or recusals.
 - 1) At the discretion of the Board President or on the request of a member, a show-of-hands or roll-call vote shall be made and the vote of members shall be recorded.
 - 2) On all votes, an indication of how each member voted, the names of the members who propose each motion and the names of the person, as given, who make statements or present material to the public body and a reference to the legal action about which they made statements or presented material shall be recorded in the minutes.
- F. All motions shall be carried by a majority of the members who vote, or as otherwise required by law.
