This acknowledges and responds to receipt of your letter dated July 23, 2012, regarding the bylaws of Local 1933 and the Procedures of LCA-769Z at Local 1933.

According to your letter, members at two consecutive meetings of Local 1933 have approved an amendment of Section IV of the Local's bylaws, increasing the dollar amount that can be spent in honor of a deceased member. According to your letter, Section IV of the bylaws should now read:

"The Secretary-Treasurer shall arrange for flowers or contributions to designated charitable organizations in honor of deceased members at a cost not to exceed \$100.00. All retired members upon retirement are to receive a UTU watch or appropriate memento."

The above bylaw amendment has been canvassed and approved by this office. It is requested that a consolidated copy of the bylaws which includes this change be forwarded to this office for inclusion in our files.

It is also noted that your letter indicates a change in LCA-769Z's Procedures has been approved, amending Section IV to now call for two (2) Vice Local Chairpersons to represent those on VRE, with one for Fredericksburg, Va., and one for Manassas, Va.

While this office generally does not review LCA Procedures or keep them on file, be advised that we will be glad to keep an updated, consolidated copy of LCA-769Z's Procedures in our files if one is provided.

# By - Laws United Transportation Union local No. 1933

1

#### SECTION I

This Local shall be known as United Transportation Union Local No. 1933. Regular meetings shall be held on rotation days, Monday through Friday (different day each month) at 11:00 am, Track 7, Conference Room, Washington, D.C.

#### SECTION II

Local dues for in service members shall be \$10.00 per month subject to change as provided in Article 48.

## SECTION III

- The President of the Local shall be paid a monthly salary of one basic day conductor rate of pay.
- The Treasurer of the Local shall be paid a monthly salary of \$450.00.
- The Secretary of the Local shall be paid a monthly salary of one basic day conductor rate of pay.
- The Local Legislative Representative of the Local shall be paid a monthly salary of one basic day conductor rate of pay.
- Each member of the Board of Trustees shall be paid a salary of one basic day conductor rate of pay for the performance of duties as specified in Article 67, Constitution.
- Any officer of this Local who is required to loose time from their regular assignment to attend to any business of this Local, shall be paid salary plus any additional time lost and expenses incurred on approval at meeting.
- All Bills of Allowance will be submitted at a regular meeting of the Local and be regularly approved.
- The provision of this Section is subject to change as provided in Article 48.

#### **SECTION IV**

The Secretary-Treasurer shall arrange for flowers or contributions to designated charitable organizations in honor of deceased members at a cost not to exceed \$75.00. All retired members upon retirement are to receive an UTU watch or appropriate memento.

#### SECTION V

All disbursements from the Local fund shall be made by check.

#### SECTION VI

The Local may pay the R.L.E.A. for rent of the meeting room not exceeding \$100.00 per month.

## SECTION VII

The Local may send, if funds permit, one officer to the UTU Regional Meeting.

#### SECTION VIII

The anniversary meeting of the Local will be in August.

#### SECTION IX

All elections will be by secret mail referendum ballot.

#### SECTION X

After giving reasonable notice to all eligible voters, these by-laws will be read at two regular meetings and if approved by a majority of the members present at each meeting voting by secret ballot, shall become effective and supersede any existing bylaws on the first of the month following the approval of the International President.

Amendments to these by-laws shall be handled in the same manner. These bylaws were adopted may 18, 2006.

# PROCEDURES UNITED TRANSPORTATION UNION LOCAL NO. 1933 LOCAL COMMITTEES OF ADJUSTMENT

#### SECTION I

Local Committee of Adjustment will meet as prescribed in Section I of the By-Laws of the United Transportation Union Local No. 1933.

#### SECTION II

Local Committee of Adjustment dues for in service members shall be \$10.00 per month subject to change as provided in Article 48.

#### SECTION III

- The Chairperson of the Local Committee of Adjustment shall be paid a monthly salary of \$650.00 and additional lost time and expenses incurred.
- The Vice-Chairpersons of the Local Committee of Adjustment shall be compensated from the L.C.A. Fund, when requested by the Chairperson of the Committee to lost time from their regular assignments to handle business of the Local.
- The provisions of this Section are subject to change as provided in Article 48.

#### **SECTION IV**

Vice-Chairpersons shall be stationed at the following Crew Bases.

Washington, DCRichmond, VARaleigh, NCCharlotte, NCFlorence, SCHuntington, WVVRE (1) Fredericksburg, VA and Manassas, VA

The provision of this Section is subject to change as provided in Article 81.

#### SECTION V

All elections for Chairperson and Vice-Chairpersons will be by secret mail referendum ballot.

# SECTION VI

After giving reasonable notice to all eligible voters, these procedures will be read at two regular meeting and approved by a majority of the members present at each meeting, shall become effective and supersede any existing procedures on the first day of the month following the approval of the members of the Local Committee of Adjustment.
