CONTINUOUS IMPROVEMENT IN THE SBM LEVEL OF PRACTICES

AMONG THE ELEMENTARY AND SECONDARY SCHOOLS

1. In line with DepEd Order No. 82, series of 2012, this office hereby advises all schools to sustain all effort in strengthening the School Based Management (SBM) practices among our schools.

2. In connection with this, the following activities shall be undertaken:

- a. Organization of the school level SBM Assessment Team who shall be in charge in assessing the level of SBM practices in their school. Suggested members of the team are:
  - Representative of the teachers' group
  - Representative of the PTA
  - Representative of the School Governing Council (SGC)
  - Representative from the Local Government Unit Official
  - School Head
- b. Capability building of the School SBM Assessment Team;
- c. Conduct Assessment of the SBM of Practice during the month of September and December:
- d. Organization of District Validating Teams with atleast three to five members and shall be chaired by the District Supervisor or the EPS assigned. The members shall be from among the elementary and secondary school heads;
- e. Validation of the SBM level of practices of all schools in the district by the District Validating Team during the months of September and October;
- f. Division and Regional level validation for schools that qualify Level Two and Three; and,
- g. National Level Validation for PASBE entry schools (Schools with SBM Level of Three).
