<u>Chairperson's Corner:</u> We have successfully held three Virtual Workshops now with attendance between 30-40 each time. The next one will be held Feb 27 on Finances in Al-Anon. March will be a repeat of the KBDM workshop on Mar 27. Check the Workshop page on the website for more info and the Zoom link.

After having an Officer's meeting on Zoom January 28<sup>th</sup> to review Assembly's situation, we will be having our **Assembly Virtually on Zoom again this year**. This is due to several factors: Currently our provincial borders are closed, travel is discouraged, and gathering limits are lower than we need for having an in-person Assembly; Most attending would not have been vaccinated by June; Many are not comfortable with large gatherings; Mt Allison University can not host conferences when "Red", and have a max # of 50 when "Orange" or "Yellow". Costs are also a factor as Registration amounts collected may not cover all our expenses if we hold a Hybrid Assembly, rather than a completely Virtual Assembly with minimal expense. Although we missed the hugs, Assembly Evaluations from last year were positive for a Virtual Assembly, especially liking no travel, sleeping in our own beds, eating our own food and not taking us away from our families for 3 days, so this was felt to be the best option given the uncertainties COVID presents for the next few months.

What will be different for our Virtual Assembly June 4-6 is the time frames. As this is Election year, there will be sessions Fri-Sat-Sun, with the time frames Sat-Sun being shorter than last year's full day. More information will be coming in the April News & Views, on the website, and from your District Reps. Stay tuned!

Our Assembly theme "*Moving Forward with Unity, Courage and Perseverance*" is very appropriate for our Election year. The COVID-19 pandemic did not change the business of our Area to attend to, but it has changed the way we get the business done. We have found ways to meet throughout, in our groups, districts and Area, kept our Unity, Persevered learning these new methods and it took Courage for us to do that. Now I need you to think about stretching yourselves a little more. We will be electing Officers, Coordinators, District and Group Reps this year. Have you considered allowing your name to stand for a position to serve Al-Anon? Any member who has served a full three-year term as a District Rep in the past, or will finish a full three-year term by Dec 31<sup>st</sup> is eligible to allow your name to stand for an Officer position. Past and present Group Reps are eligible to allow your name to stand for District Rep. Any active member, who is also not an AA member, is eligible to allow your name to stand for Group Rep. And any active member may stand for a Coordinator position. One thing I can say from serving Al-Anon is that you will grow and learn from the experience, and are never alone. There are many past and present trusted servants who can assist you, answer your questions, and support you. Please think about it, and reach out if you have questions.

# **Delegates Report:**:

Well, we can say that 2020 was an exceptional year and as an Al-Anon organization, we have had so many firsts that they are now hard to count them all. From face-to-face meetings to telephone conferencing and zoom. Groups have even tested the hybrid meeting where some were in person and others at the other end of a telephone or a computer. As an Area, you have done a marvelous job of staying connected to each other, groups, district and the area and I thank each and everyone for their participation this past year. All of these were huge accomplishments, which we did not even dream we would be doing. The World Service Conference in April of 2020 was virtual. Our Maritime Assembly and the AWSC meetings were also virtual, well-done Area 91. We can achieve and can overcome huge obstacles when we must.

The World Service Office sent out a summary of the current financial outlook in December, which is unusual, but due to the financial restraints placed upon the organization by covid-19 and the call for member support, it was deemed necessary to post the financial status early. Two items in this letter from the Treasurer, first a huge thank you to the membership who came through in amazing fashion and have provided the monetary support to the World Service Office that with contributions to come in over the month of December and second; our financial ledger is expected to be in the black for 2020. Thank you all.

I have been advised that many groups continue to support the WSO from their savings of not paying rent. That is great news. I want you to be aware that we must continue to support our districts and area as well. When we do this well enough, all our service arms benefit from our contributions. The World Service Conference scheduled in New York this coming April 11 – 17, 2021 has been cancelled and will be conducted virtually. The Delegates are already working on reports, finalizing thought forces, task forces, and other committee functions we have been working on in committees. Most of these must be completed for the Board meeting review in February, then the translation into all three languages, French, Spanish and English. As much as I will miss meeting all the folks at Conference and this year was to be the visit to Stepping Stones, this just means that we will have to do this another time on our own. With the amount of Covid-19 still around and the airlines reducing flights, I am OK with staying in Nova Scotia. Zoom meetings have been good to us.

We are all hoping that this pandemic will ease up and we can get back to some sense of normalcy. If anyone has a crystal ball, would you advise when this may be?

The only position that does not have a defined term is the Literature Depot Coordinator/Manager. Now is the time to plant the seed of a service position in someone's mind that you believe would do a good job for the Maritime Provinces Assembly.

Hi Everyone – Mid-February by the time you are reading this. NB has not been doing as well as NS and PEI Covid-wise. At time of writing, various parts of our Province are in various stages of shutdown. Practicing the Steps and Traditions on Covid can improve our well-being, so not all is lost. Face-to-face meetings and real "hugs" will be welcomed when this is over.

<u>Insurance:</u> Just a gentle reminder that insurance payments are due - \$30 per group. I would love to receive these during March and April to enable a good accounting for reporting to Assembly in June. Districts can submit one payment for all their groups and then collect from the groups if they wish. This makes it easier (especially for me – Ha! Ha!), and ensures everyone is accounted for.

**E-transfers**: E-transfers save trips to the bank, trips to the post office, and cost of stamps and envelopes. Maybe you would like to try it...... Everything is done on line through whatever bank you use. You simply do an e-transfer to the e-mail address, which was set up specifically for our Assembly bank account. The e-mail is <a href="mailtimeassemblyf@gmail.com">maritimeassemblyf@gmail.com</a>. When you do this you get an immediate receipt and I get the e-mail message that you send with the e-transfer saying what it is for (insurance/contribution) and who it is from (group/district names and numbers). The money will be deposited automatically into our Maritime Assembly Fund account instantaneously. If you forget the e-mail address, Mickie has posted it on the website.

<u>Sending Cheques:</u> If you are sending your money by cheque, please, please be sure to make the cheque payable to "Maritime Assembly Fund" (not Area 91) and remember we are in 2021.

We encourage all interested Districts to put their name in for News and Views Coordinator. It is a rewarding position and bonus you get to be first to read the news.

#### **Alateen and AMIAS Report:**

The Alateen Chat Line is no longer in existence. The moderators of the former chat room are now moderating the online Alateen meetings on cell phones or other mobile devices. The meetings are held on Monday evenings. The standard PC is no longer useful for this. All Al-Anon members, especially the Alateen Moderators, are asked to download the new app onto their devices and attend several Al-Anon meetings online to get some practice before going to moderate the online Alateen meetings.

It is very much a learning curve for some of the Moderators to get used to these online meetings as some are a bit technologically challenged. It still requires a lot of practice to get used to it. There have been the anticipated bumps and curves along the way, but everyone is becoming accustomed to this new format (using cell phones and other mobile devices). The new format of the Alateen online meeting is Zoom-powered - **not a Zoom meeting** - which uses the same format as a Zoom meeting.

One AMIAS has decided to retire from being an AMIAS. To that person, Bev G., on behalf of the Area I would like to thank you for all your years of service as an AMIAS and for all the time you volunteered as a Moderator

Moderators with Apple devices are not able to screen share information that they have been asked to download onto their devices. It would appear that android devices are more adaptable to sharing printed matter for the teens to read during the meetings. This is something WSO technicians are working on to allow those with iPhones or iPads to do some of the more technical work.

The online Alateen meetings in which I participated were slow at the start, but recently there have been more teens attending and they have been asked to chair their meetings, allowing much more participation by the teens, with the Moderators watching for safety and confidentiality of information given at the meetings and for the teens.

- 2) All current AMIAS will be required to get a Vulnerable Sector Check and Criminal Record Check later this year. For those who **do not** live in Districts 7 & 11, please go to the Area website and download the generic permission letter to be taken to your local policing jurisdiction. <u>Public Outreach Coordinator:</u> It has been a year since Canada announced the first confirmed case of COVID-19 on 1/25/2020. A few weeks later, on March 22nd, a state of emergency was declared here in Nova Scotia. We are still under that same state of emergency. The restrictions have been


difficult for us all, but for those who live alone, or those in long-term care, they have been particularly isolating. Vaccinations are on the horizon, but with supply delays, we may not see them until late fall

When I asked to be your Public Outreach Co-ordinator two years ago, I never imagined we would be faced with such rules, regulations, and restrictions. It has certainly been a learning experience for me. I am so grateful to all of you who have risen to the challenge and continue to make a difference in the Lives of those families struggling with the effects of Alcoholism.

WSO took over the distribution of Al-Anon's Public Service Announcements. In November 2020, they confirmed that members' involvement in the PSA Public Outreach Project was to be limited to maintaining existing media relationships and outreach to other non-media outlets such as movie theaters, schools, and institutions, or sharing the PSAs with their social media networks.

If you have members who already have commitments from stations to play our PSAs have them email the WSO at <a href="media@al-anon.org">media@al-anon.org</a> They will make sure the new vendor connects with them to ensure they are able to access the spots.

The new issue of Al-Anon Faces Alcoholism, formally known as AFA 2021, will be the first issue printed without a year on the cover. The new issue is available to be downloaded

In these times when we can not hand out literature, and until the New Newcomer's package is available On-Line, these words of Help & Hope are perfect to give any Newcomers to your meeting.

#### Per Scot Powers from WSO:

"It is the Public Outreach magazine. One way we distribute them is to give copies to professionals to handout to their clients/patients. They are also left in places where literature or information can be freely exchanged such as library or civic buildings. The goal is to get the AFA magazine into the hands of newcomers and potential newcomers by any means necessary.

The Forum is not a very newcomer friendly magazine, since there are only 3 articles in the entire magazine chosen with the newcomer in mind, whereas in the AFA all the articles with the exception of the 3 professional articles were chosen with the newcomer in mind.

What is more important, the AFA is a free download, which makes it a great resource for new members."

- No physical conventions; school fairs; health fairs
- People working from home- not in offices
- Doctors and other professionals not available in their offices
