### Advertising

The Artist will:

- Supply the Client with twenty 11 x 17 color posters to display in the community.
- Email news subscribers on the Monday, Wednesday, and Friday before the performance.

### Setup

- Performance setup will be the responsibility of the Artist (includes backdrops, stage arrangement, lighting, sound equipment, and instruments).
- The Client will provide \_\_\_\_\_ {tables, chairs, etc.}.
- The Artist has the full right to sell merchandise at the event and may request an area and tables for this purpose.

### Cancellation

- The Client may cancel the performance 30 days or more prior to the performance date and receive a full deposit refund.
- If the Client cancels less than 30 days prior to the performance date, the Client forfeits the \$500.00 deposit.
- The Artist may cancel the performance at any time due to an Act of God.
