

#### Reserves

Cash savings to cover Total Liabilities (\$295,438 - this year), as well as ongoing project funds.

#### **Endowment Fund**

Donated funds to assist lowincome residents with rental expenses.

#### **Structures**

This includes the original cost of the buildings 30 years ago plus the cost of major improvements to date.

#### **Total Liabilities**

Reserved funds earmarked for ongoing projects, and refundable estate and life lease fees.

#### **Current Deficit**

Total dollar amount of expenses, which exceeded revenue, excluding capitalized improvements.

## The BSRC Extends a Hearty Welcome To Our New Handyman, Tim Sochacki

One year ago, Tim Sochacki was enjoying a predictable life, working in his father's construction and real estate business, which he had done since he was 13 years old, and attending meetings with the Detroit Metro Class – a legacy of his mother, Sophie Sochacki, who passed to her reward in 2008. Then the LORD stepped in and decided to stir up the waters of his life a bit.

Tim was attending the 2018 International Convention in Poland when he learned the BSRC had an opening for a handyman. He responded when the ad was posted on Old Ron. Ed Heidelbach interviewed him, then arranged a teleconference with the Board. Tim accepted an offer and arrived at his hitherto unseen new home on December 1, 2018.

One of his pleasant surprises upon arriving at the BSRC was driving through the wrought iron gates into a campus of exceptional beauty and serenity. In addition, Tim says he's been overwhelmed with expressions of appreciation and encouragement from everyone since the day he arrived.



As Handyman, Tim is responsible for maintenance for 28 units, plus the Main House and grounds, landscape, and outbuildings. Outside contractors assist with certain tasks, but he is the main eyes, ears, and hands for all the BSRC's general upkeep, the "go-to guy" for emergencies, malfunctions and things that come up in the middle of the night. A few days after he arrived, Tim got his first middle-of-the-night call. A sister saw a veritable lake forming in the central courtyard from her second-floor window. Tim,



with able assistance from Jim Tower, discovered the underground leak was from a fire hydrant line at the back of the property. After calls to the authorities, the water line was shut off, and "peace like a river" descended.

Tim has earned the appreciation and affection of so many residents in the six months he's served as the Handyman. He demonstrates a strong work ethic and skillset. He is up-beat... enthusiastic... always smiling... eager to be of help... loves the Lord... loves the brethren... easy-to-work-with... "easy to be entreated"... eager to know how he might improve his performance... humble... heart-of-gold... salt-of-the-earth. We are so grateful that when we needed a Handyman, the Lord sent Tim.
