Health/Code Officer Report New Haven Hose Report

Tom Currey, Health/Code/Zoning Officer stated the City's standard for grass is 12 inches, "so please cut your grass." He also stated you need to get a permit from the City and the County for pools two feet or taller and a fence for 2 to 4 feet to enclose that pool in. Currey also stated if you have a pool you put up in the summer and take down at the end of summer, you need to get a new permit each time you put it up, noting that is a State of Pennsylvania Law.
