We are pleased that you have considered coming to us for counseling. Counseling is a very personal shared interaction between two people and should not be entered into lightly. The following information is designed to help you know what you can expect from the counseling process. Counseling has limited effectiveness if you only concentrate on the issues and concerns once a week. Therefore, as part of our approach, you will be asked for your personal active effort throughout the week. All of our clients are encouraged to prepare for each session and review between sessions. You will be asked that you do specific activities and/or read specific books that will help you expedite the time it takes for you to address your concerns. The process of therapy and recovery requires a great deal of work and understanding. To help accomplish this, a variety of methods may be recommended to assist you including: individual counseling, family counseling, and or group counseling. Due to the personal and private nature of counseling, your confidentiality will be maintained as directed by law. Ethical standards restrict dual relationships and it is illegal to have sexual contact with your counselor. We are not forensic therapists. Due to the therapeutic nature of our services we choose the option to not participate in legal proceedings.

The fees are: Dr. Steve is \$145.00, LPC & LCSW \$120.00, LAC & LSW \$90.00, Interns is \$60.00 payable at each visit. We attempt to cooperate with insurance providers, but this does not guarantee coverage. If you are considering insurance companies for reimbursement, you should have already contacted your insurance provider and discuss this option at your first visit with us. We maintain a 24 hour answering service to avoid the charge in the event an appointment is not attended. Missed appointment fees are \$30.00 or the co-pay whichever is greater. Returned check fees will be required to be paid.
