RELEASE AND HOLD HARMLESS AGREEMENT

1. I, _____, the undersigned, have read and understand, and freely and voluntarily enter into this Release and Hold Harmless Agreement with Pacific Coast Vaulting Club, The Frankel Family, their heirs and employees and volunteers understanding that this Release and Hold Harmless Agreement is a waiver of any and all liabilities.
2. I understand there are inherent dangers that I could incur in mounting, riding, vaulting, walking, and feeding horses, mine or others; including, but not limited to any interactions with other horses. Understanding those risks I hereby release Pacific Coast Vaulting Club and the Frankel Family, its owners, officers, directors, shareholders, equine professionals, employees, and anyone else directly or indirectly connected with Pacific Coast Vaulting Club (hereby referred to as REPRESENTATIVES) from any liability whatsoever in the event of injury or damage of any nature (perhaps even death) to me, anyone else, or my horses caused by or incidental to my electing to mount and ride horses owned or operated by Pacific Coast Vaulting Club, its REPRESENTATIVES, or me.
3. I understand and recognize and warrant that this Release and Hold Harmless Agreement (hereby referred to as AGREEMENT) is being voluntarily and intentionally signed and agreed to and that in signing AGREEMENT I know and understand that this AGREEMENT may further limit the liability of Pacific Coast Vaulting Club and its REPRESENTATIVES to include any activity, whatsoever, involving horses and activities at Pacific Coast Vaulting Club including death, personal injury, and/or damage to property.
4. I recognize and agree that I know which REPRESENTATIVES I will be working with and acknowledge that I agree said REPRESENTATIVES have made reasonable and prudent efforts to determine my ability to engage in equine activities and have sufficient knowledge of my equestrian skills as to relieve, release, and hold harmless said REPRESENTATIVES from any continuing duty to monitor my equestrian activities.
5. I further voluntarily agree and warrant to Release and Hold Harmless Pacific Coast Vaulting Club and its' REPRESENTATIVES from any liability whatsoever, including but not limited to: any incident caused by or related to said REPRESENTATIVES' negligence; relating to injuries known, unknown, or otherwise not herein disclosed, including but not limited to injuries, death, or

Property damage from mounting, riding, vaulting, dismounting, walking, grooming, feeding, use of horse barns, paddocks, trails, or arenas, in any capacity; falling off horses whether horses are immobile, moving; or my failure to understand any REPRESENTATIVES directions relating to my vaulting or otherwise use and control, or lack thereof, of horses. In the case of vaulting a REPRESENTATIVE of Pacific Coast Vaulting Club will control the horse.
