7.	<p>a. <u>2/81 Intake Charter/ Guidelines.</u> Following a lengthy discussion, all those present have acknowledged the requirements for a set of guidelines in the running and management of the association.</p> <p>The objectives of the association are two fold:</p> <p style="padding-left: 40px;">(1) To promote unity and a sense of togetherness among 2/81 Intake members through social and welfare events as sponsored by the Association.</p> <p style="padding-left: 40px;">(2) To Provide welfare assistance to its members as and when needed.</p> <p>The following guidelines will now be applied in the governance of the 2/81 Intake association:</p> <p>b. <u>Membership & Contributions.</u> All of 2/81 intake are members of the association and as such are required to make a set contribution to the association as determined by the committee. The amount set by the committee is as below:</p> <p style="padding-left: 40px;">(1) For those who have paid a membership fee ever since its inception, they will pay a renewal fee of £10.00 each year on the day of get-together. Those who are unable to attend are to make the payment in liaison with the treasurer.</p> <p style="padding-left: 40px;">(2) For those who have arrived recently and have not paid the membership fee at all, they are to pay £40.00 as a membership fee and an yearly renewal fee of £10.00 (in total £50.00).</p> <p style="padding-left: 40px;">(3) All members who are in the register are to pay £10.00 as a renewal fee in a yearly basis regardless of their attendance on summer gathering.</p> <p>c. The fee/ contribution will be reviewed by the committee as and when necessary to be in step with modern times and prevailing situations.</p> <p>d. Members who have not yet registered and have no intention/ wish to join the association can do so without an explanation. For such members, the association is not obliged to make a financial assistance should they run into financial difficulties. Nevertheless, a</p>	All

	<p>donation will be collected.</p> <p>e. <u>Financial Assistance</u>. If any members come into financial difficulties due to circumstances involving death, then £1000 will be granted from the fund within 24 to 48 hours of being approved. This money will be replaced from an equal collection of the association's membership.</p> <p>f. If there is a request for financial aid through extenuating circumstances other than death or illness, then a written request must be submitted to the association committee for approval. The amount of financial aid in these cases will be determined on a case by case basis.</p> <p>g. While this form of aid is solely for those members registered and does not normally extend to members dependants, under extreme cases the committee will consider waiving this clause following a case review.</p> <p>h. <u>Committee Tenure</u>. Each committee will have a term of three years. If any member needs to step down before their term ends, then applications for the position will open, and if no applications are forthcoming a replacement will be selected by the committee.</p> <p>i. <u>Attendance on Association Events</u>. All members, where possible, must attend the annual gathering and any meetings organised by the association without fail.</p> <p>j. <u>Facilitation</u>. During the summer gathering, we will offer felicitations to the following:</p> <ul style="list-style-type: none"> • Those starting and graduating from university • The birth of a child • Ladies passing driving test
