- 1) I am represent that I am the parent or legal guardian of the participant(s) named below or I have obtained permission from the parent/legal guardian of the complete this agreement. I hereby execute this agreement without concern.
- 2) I understand that entry, by myself and the participant(s) named, constitutes consent for JollyRogerLand to use any film, video, or likeness of participant for any purpose whatsoever, without payment to the participants.
- 3) The undersigned knowingly and fully assumes all risks. Known and unknown , associated with participation in activities at JollyRogerLand, and hereby forever waives, releases and discharges any and all claims, liabilities, actions and causes of actions for damage to personal property or injury to person arising from such participation, including without limitation, death, disability, personal injury, property damage, or theft. This release and waiver covers risks of death, serious injury, and property loss whether arising from (a) negligence or carelessness in the part of the persons or entitles being released and other participants, or (b) tort, contract, strict liability or otherwise. To the fullest extent allowed by law.
