1. Cancellation Policy

I have read and understand **Emerge Dance Academy's cancelation policy**. The studio requires one months' notice of cancelation. At the time of cancelation, I will not receive a refund for the current month's fee, June tuition fee, costume, or competition fees.

3. Attendance Policy

Emerge Dance Academy expects students to attend their classes on a regular weekly basis. If I am planning a vacation outside of regular holiday dates, I will notify the instructor well in advance. This is important for competitive and recreational classes. I understand that dress rehearsal, any competitions as well as the recital require MANDATORY attendance. My child is registered in weekly classes and understands the importance of regular attendance in the class (es) in order to properly progress in their training. I understand that my child cannot text, email or call in their own absences.

4. Competition Classes

All dancers in competitive classes will be allowed a **limited number of missed classes** between Sept - April. At the discretion of the instructor, the dancer may or may not compete due to missed classes My child is registered in competitive classes and understands regular weekly attendance is necessary in order to participate in competitions. I understand that competition attendance is mandatory and that if for some reason my dancer is unable to attend that it could result in being taken out of future competitions or choreography. I agree to pay all competition fees and agree to entering my dancer is up to 3 competitions.
