

## 2. ENROLLMENT CONTRACT

1. We enroll our child, \_\_\_\_\_, in The Montessori at Sawyers Glen's full 9 1/2 month school program (September through mid-June) and intend to complete the entire school year unless unforeseen circumstances arise.
2. We understand the Montessori is a 3-year program and that registration of our child in The Montessori at Sawyer's Glen Kindergarten is expected, but not required.
3. We understand and agree that the Registration Fee is due upon registration and is Non-Refundable.
4. We agree to pay all tuition payments as set forth in the Fee Schedule. If we elect to participate in the Monthly Tuition Payment Plan, our payments will be made in advance by the 25th of each month from the time of registration through June, 2022. If we elect to make a single, annual payment, we agree to pay at the time of registration.
5. If we elect to participate in the Monthly Tuition Plan, we understand and agree to pay a deposit in the amount of one-half of one month's tuition. This deposit is due on August 13, 2021, or upon registration, and we further understand that this payment is Non-Refundable.
6. If we elect to participate in the Monthly Tuition Plan, we understand and agree to pay a final tuition payment on June 1, 2022 equal to one-half of one month's tuition.
7. We understand and agree to pay a \$35 late fee if our payment is not made prior to the third day of the month following the month in which payment is due.
8. We agree to give a 30-day notice of withdrawal of our child prior to withdrawal, and to pay in full for that month. (Both parents must sign the school withdrawal form, found on page. 4.
9. We understand that if we withdraw our child before June 15, 2022, we will forfeit our prepaid tuition deposit.
10. We understand that there is a \$1 late fee for every minute that we are late picking up our child from school **(Payable that day) or you will be billed**. There is a 5 minute grace period.
11. We understand that we are responsible for signing up for and bringing snack within the allotted time frame (1 week) or we will be charged a fee of \$10.00.
12. We agree and understand that we are still responsible to pay our child's full tuition amount if we choose to take a vacation during scheduled school dates. **Montessori at Sawyer's Glen is not responsible for responsible for make-up days, including illnesses and/or snow days.**
13. We understand and agree that, in the event an attorney is employed to collect any amount due hereunder, we agree to pay all reasonable attorney's fees and costs incurred by Montessori at Sawyer's Glen School for the collection of the amount due.
14. We have read and agree to the school's policies and fees set forth in the Fee Schedule.
15. RCW 43.215.535 allows providers to opt out of the law to carry insurance and I have chosen to opt out.
