- 2. Business Resolution 3
 - a. Title: A Resolution to Endorse, Adopt and Submit an Alaska Board of Fisheries Proposal to Address the Collection of Wild Amphibians and Permits for Amphibian Possession.
 - i. Votes: 11 in favor, 2 opposed
 - ii. Discussion: None
 - iii. Motion carried: Adoption of Resolution 3.
- 3. Bylaw Revision Article III Section 1
 - a. ADD: Full membership in the Society shall be available to any individual demonstrating an interest in herpetology. Only Full Members may hold elective offices in the Society and officially represent the Society on business pertaining to its functions. Full members must be sixteen years of age or older.
 - i. Votes: 11 in favor, 1 opposed
 - ii. Discussion: None
 - iii. Motion carried: Adoption of Article III Section 1
- 4. Bylaw Addition Article III Section 4
 - a. ADD: Junior Membership: all members under the age of 16 will be considered a junior member and enjoy all membership benefits except for voting and elections or official business of the society.
 - i. Votes: 11 in favor, 1 opposed
 - ii. Discussion: None
 - iii. Motion carried: Adoption of Article III Section 4
- 5. Dues I

a. Should previously established dues remain the same as in previous years?

i. Votes: 13 in favor

6. Dues II

- a. If Article III Section 4 were applied should junior members have a membership fee in the amount of \$5 per year?
 - i. Votes: 12 in favor, 1 opposed

 - iii. Motion carried: Dues for junior membership will be \$5/year.

7. Website Renewal

- a. Allow the AHS executive board spend up to \$150 of its treasury for a two-year renewal of its website?
 - i. Votes: 13 in favor
 - ii. Discussion: None
 - iii. Motion carried: \$150 of treasury to be spent on website renewal.
- 8. 501(c)(3) Application and Funds for Grants Program
 - a. Allow for \$200 of treasury to go toward research grants program.
 - i. Votes: 10 in favor, 3 opposed
 - ii. Discussion: None
 - iii. Motion carried: AHS will commit \$200 from treasury toward research grants program.
- 9. Pick-Click-Give Program
 - a. Allow for \$250 of treasury towards an application fee to participate in Alaska PFD Pick-Click-Give Program in 2015, assuming that this amount makes up less than 50% of the treasury when the application is submitted?
 - i. Votes: 6 in favor, 7 opposed or "depends"
 - ii. Discussion:
 - a. Seth Perry in favor, thinks it will pay for itself given that we could reach enough people.
 - b. Amanda Gibson it depends; seems risky.
 - iii. Motion denied: AHS will table this question and reevaluate where the treasury stands in early Spring and if it is possible at that time.

 - a. Expand the kit; make duplicates available for Anchorage, Fairbanks, and South East Alaska.
 - b. Transfer to Jennifer
- 2. Permit from ADF&G to use herps for education
 - a. Permit given to AHS that allows us to have 3 rough-skinned newts and 3 wood frogs collected from the wild to be kept in captivity to use in educational events.
 - b. Joshua Ream has 1 rough-skinned newt (from Stikine River) and 2 wood frogs (from Jewel Lake) available for use at events.
 - i. Wood Frog Newts:
 - 1. Two BBC films
 - a. Documentary on AK wildlife on hibernation stages
 - b. Children's program called "Naomi's Nightmares of Nature."
 - i. BBC made a donation of \$200 to AHS treasury
 - i. Rough-Skinned Newt:
 - 1. Caught in submerged trap on Stikine River
 - a. "Lazarus" newt wakes from the dead.

Events:

- 1. Current:
 - a. Dragonfly Festival in Fairbanks
 - i. Coordinated by Allyssa Morris through Fish & Wildlife Service
 - 1. Family event in Cramer's Field
 - 2. Catch, Collect, and Identify dragonflies
