Thanksgiving 2021 Mission: Feeding the Homeless and Needy families with children

In January 2020, there were 580,466 people experiencing homelessness in America. Most were individuals (70 percent), and the rest were people living in families with children. They lived in every state and territory, and they reflected the diversity of our country.

Homeless programs and systems provide shelter for most people experiencing homelessness (61 percent). However, significant variation exists among subgroups. For example, children are often a priority for homeless services systems. As a result, families with children are least likely to be unsheltered (only ten percent of unsheltered people are living in families with children). However, young people not living with their families do not enjoy the same access to services—50 percent of unaccompanied homeless youth are unsheltered. Individuals experiencing homelessness on their own are particularly vulnerable. Most (51 percent) live in places not meant for human habitation. Those who are chronically homeless are most likely to be in these circumstances—66 percent are without any shelter at all.
