The home at 14134 Shoal continues to be an ongoing issue since it is bank owned and has been empty for many years. M&A is at-

tempting to have the bank step up and take care of the property. There is now a dead tree on the property that needs to be removed.

Our lawn maintenance company (ALOTT) has recently replaced sod in the community. The HOA board did not select the areas to be re-sodded, so please don't think you were snubbed by this board.

You all probably have received a number of items in the mail dealing with the gulf course or the future development of property across from our entrance or behind our community. There isn't much we can do about progress, but there is some news on the Links (which most of you already know).

On Thursday, June 18, County Commissioner Jack Mariano along with two members from code enforcement, invited HOA Board Members from all affected communities to attend a meeting at the clubhouse. In a nutshell, fines in excess of \$52000 were levied against Matt Lowman and the golf cart company that opened in the pro shop. Fines can continue to accrue until their court dates. However, the golf course immediately mowed around the perimeter of the course - up to 30 feet from propertv lines.

There are many homes in the community that have made exterior changes without submitting an Architectural Form. Changing garage lights, painting your driveways, screening front porches, or changing landscaping in front of your home are just a few of the items that seem to slip through the cracks. For the most part, all the above would probably be approved

without a question. Changes made to your property are filed at Management and Associates. So, if you have made any changes you should still fill out the form and submit it. Forms are online at our website mentioned above.

Finally, only covered trash cans are allowed out the night before trash pick-up. Trash bags can be placed out on the morning of pickup.

We don't want to be the HOA depicted in the GEI-CO insurance commercial!!!! But we do want to keep our community looking good which is thanks to everyone who takes pride in their property.
