CDBG Housing Project Update – David Weaver stated we need a motion to move remaining CDBG homes from Substantial Reconstruction to Buyers Assistance. Motion made by Jane Baine, seconded by Chris Ellsworth, to move remaining CDBG homes from Substantial Reconstruction to Buyers Assistance. Ayes: Aldermen Baine, Welch, Hogan, Ellsworth. Nays: none. Motion carried. David stated this will apply to the last two homes. We will need to appoint a 504 Coordinator as a requirement of the CDBG program.

Microphones – Alderman Welch requested an update on the microphones. Alderman Hogan stated he received a quote for \$1,430 from TEC. David Weaver stated another bid was \$908 for troubleshooting and system would have 1-yr warranty. Motion made by Barbara Welch, seconded by Jane Baine, to approve moving forward with installing microphones. Ayes: Aldermen Baine, Welch, Hogan, Ellsworth. Nays: none. Motion carried.

Update on City Matters: Alderman Baine questioned increase on sewer bills. David Weaver stated 4<sup>th</sup> year 12% increase. People on wells are charged according to Joplin code. Their code spercedes ours per the contract. They can install and acceptable flow meter – approved by City of Joplin.

property, Business Licenses, and stack of mattresses on Duquesne Rd. Alderman Ellsworth requested City Clerk add building permit language to the next P&Z Agenda.

David Steele, 3201 E 13<sup>th</sup> Street, spoke about sewer at apartment complex on 7<sup>th</sup> Street.

**New Business:** FY17 Audit – David Weaver stated Mense qualified opinion is that we are not in compliance due to Cash Basis Accounting. David went over the specific issues cited in the Audit.

City Treasurer Bond: Motion made by Adam Hogan, seconded by Chris Ellsworth to approve City Treasurer Bond of \$100,000. Ayes: Aldermen Baine, Welch, Hogan, Ellsworth. Nays: none. Motion carried.

Appoint 504 Coordinator - Motion made by Barbara Welch, seconded by Jane Baine to appoint the City Clerk as the 504 Coordinator. Ayes: Aldermen Baine, Welch, Hogan, Ellsworth. Nays: none. Motion carried.

Street lights (Piper Glen Subdivision) – David Weaver provided quoted prices from Empire on street lights for the subdivision. It is based on brighter or dimmer bulbs. Schuber Mitchell is requesting 4 street lights. Motion made by Adam Hogan, seconded by Barbara Welch to approve installation of 4 lights with brighter bulbs. Ayes: Aldermen Baine, Welch, Hogan, Ellsworth. Nays: none. Motion carried.

Update on Commissions and Committees – Gary Heilbrun stated he was accepting the written resignation of Stephen Williams and Mickey Sherman from the Planning & Zoning Commission. We will need a Special Meeting before the next P&Z Meeting to appoint a new member or there will not be a Quorum.

**Other Business Deemed Necessary:** Brandi Miller asked about mailing information on the Use Tax. David Weaver stated hiring board met to interview Chevelle Kidd. Motion made by Chris Ellsworth, seconded by Adam Hogan, to hire Chevelle Kidd as part-time Administrative Assistant at \$14.50/hr, and increase to \$15.00/hr after 90-day probation period. Pending background check and physical. Ayes: Aldermen Baine, Welch, Hogan, Ellsworth. Nays: none. Motion carried.
