

CWA Minority Caucus Bylaws



Article I - Name

This Caucus shall be known as CWA (Communications Workers of America) Minority Caucus.

Article II – Objectives

The Objectives of the CWA Minority Caucus are as follows:

- 1. To actively pursue fair and equitable treatment of minorities and other members at all levels of the Union.
- 2. To establish a positive and active rapport with the minority members of CWA.
- 3. To encourage the education of our minority members on union policies at the National, District and Local levels through active networking.

Article III – Membership

Section 1: Eligibility

Any person eligible for membership in the Communication Workers of America, as defined in Article V, Section I of the CWA Constitution, shall be eligible for membership in the Caucus.

Section 2: Application

Membership in CWA Minority Caucus shall be obtained upon evidence of membership in good standing in a CWA Local.

Article IV - Caucus Assessments

Each member of the Caucus shall tender dues in the amount of \$25.00 (twenty-five dollars) per year. The dues will be for a calendar year: January 1 through December 31.

Article V – Caucus Meetings

Section 1: Caucus Meetings

- A. Meetings of the CWA Minority Caucus shall so be scheduled at each CWA Convention and whenever designated by the President.
- B. CWA Minority Caucus meetings shall not conflict with CWA Convention Proceedings.
- C. Only CWA members who are Minority Caucus members in good standing shall vote at a General Caucus Meeting.

Section 2: Executive Board Meetings

The Executive Board shall meet at least once during the course of a CWA Convention.

Article VI - Conduct of Meetings and Quorums

Section 1: Meetings

- A. CWA Minority Caucus Meetings, Executive Board Meetings and all other meetings of the Minority Caucus shall be conducted in compliance with these Bylaws and in conformity with the Union Constitution. Where the Bylaws and Union Constitution do not apply, ROBERTS RULES OF ORDER shall govern.
- B. The President shall appoint no less that two (2) members to serve as Sergeant-at-Arms at General Caucus Meetings and at Caucus Membership Meetings.

Section 2: Quorums

- A. The number constituting a quorum for Caucus General Membership Meetings shall be those members in attendance.
- B. A majority of its members in attendance shall constitute a quorum of the Executive Board.

Article VII - Order of Business

The order of business for all meetings shall be as follows:

- 1. Call to order
- 2. Invocation
- 3. Roll Call Executive Board
- 4. Approve minutes of last meeting
- 5. Communications
- 6. Officer's Reports
- 7. District Reports
- 8. Committee Reports
- 9. Old Business
- 10. New Business
- 11. Good and Welfare
- 12. Adjournment

Article VIII - Caucus Officers and Executive Board

Section 1: Minority Caucus Officers and Executive Board

The officers and Executive Board of CWA Minority Caucus shall be:

- 1. President
- 2. Vice President
- 3. Treasurer
- 4. Assistant Treasurer
- 5. Recording Secretary
- 6. Assistant Recording Secretary
- 7. District Representatives

Section 2: Duties of Minority Caucus Officers and Executive Board

Duties of the President

The President shall:

- a) Have full authority to execute the policies of CWA Minority Caucus as so established.
- b) Call and preside over all CWA Minority Caucus meetings.
- c) Be the official spokesperson for the CWA Minority Caucus.

Duties of the Vice President

The Vice President Shall:

- a) Assist the President and work under the President's direction.
- b) Assume the Office of the President in the event the Office becomes vacant; and shall thereupon assume all responsibilities as President for the unexpired term.

Duties of the Treasurer

The Treasurer shall:

- a) Be custodian of all assets of the Caucus and shall submit a financial report at Caucus meetings.
- b) Pay the proper bills and expenses of the Caucus as approved by the President when evidenced by satisfactory statements, with checks signed by the Treasurer and countersigned by the President.
- c) Deposit all funds belonging to the Caucus in a bank or banks approved by the Executive Board.

Duties of the Assistant Treasurer

The Assistant Treasurer shall:

- a) Work under the direction of the President and Treasurer.
- b) Shall serve as the Member Committee chair.
 - 1. Shall oversee policy and procedures for the Membership Committee.
 - 2. Shall be responsible for the forwarding of district membership lists to District Representatives.
 - 3. Shall be responsible for sending membership renewal notices to all Caucus members on December 1st of each year.
 - 4. Assume the Office of the Treasurer in the event the office becomes vacant and shall thereupon assume all responsibilities as Treasurer for the unexpired term.

Duties of the Recording Secretary

The Recording Secretary shall:

- a) Maintain a record of all Caucus meetings.
- b) Provide copies of minutes at Caucus meetings.
- c) Send out meeting notices.
- d) Provide Executive board with copies of minutes as soon as possible.

Duties of the Assistant Recording Secretary

The Assistant Recording Secretary shall:

- a) Work under the direction of the President and Recording Secretary.
- b) Assume the Office of Recording Secretary in the event the Office becomes vacant; and shall thereupon assume all responsibilities as Recording Secretary for the unexpired term.

Duties of the District Representatives

The District Representatives shall:

- a) Work under the direction of the Caucus President.
- b) Collect dues and forward all money and applications to the Caucus Treasurer by Certified Mail/Returned Receipt Requested.
- c) Communicate (National and District) Caucus meetings and business information as received to the members of their District.
- d) Act as the District Membership Coordinator.
- e) Shall serve on the Caucus National Membership Committee.
- f) Establish a rapport with the District Vice President in order to promote Caucus objectives and full participation of minorities in their District.
- g) Submit a written report of district activities at all Executive Board meetings.
 - 1) A report shall be given at regular Membership Meetings of the Caucus.
- h) In the event a District Representative cannot perform their duties, the President may appoint an alternate District Representative to carry out the mission of the CWA Minority Caucus.

Article IX – Nominations, Elections of Caucus Officers and District Representatives

Section 1: Nominations of Caucus Officers

- A. The President, Vice President, Treasurer, Assistant Treasurer, Recording Secretary and Assistant Recording Secretary shall be elected separately by secret ballot after nomination from the floor.
- B. Beginning with the election held in 1985, their term of office shall be three (3) years or until their successor is duly elected.
- C. In the event of a vacancy in the position of an Officer, the President of the Caucus shall appoint a replacement until such time the vacancy can be filled by the election of the Officer's position. The election shall be held at the next convention immediately following the vacancy.
- D. In the event of a vacancy in the position of a District Representative, the President of the Caucus shall appoint a replacement, until such time the vacancy can be filled by the election of a new District Representative. The election shall be held at the next convention immediately following the vacancy.
- E. The President shall notify all members in writing that an election will take place at such convention.
- F. All elections shall be determined by plurality vote.
- G. Newly elected Caucus officers and District Representatives shall take office at the Convention in which they are elected.

Section 2: General Provisions

- A. Only members in good standing 30 days prior to nominations shall be eligible to vote or hold office.
- B. A Representative from each District shall be nominated and elected from the group to be represented in a Caucus meeting during election of Caucus Officers.

Article X - Recall of Caucus Officers

Elected Officers of the Caucus may be recalled for willfully violating these Bylaws, misappropriating Caucus funds and bringing the Caucus into disrepute.

Article XI - Executive Board

Section 1: Caucus Executive Board

The Caucus Executive Board consists of:

- a) President
- b) Vice President
- c) Treasurer
- d) Assistant Treasurer
- e) Recording Secretary
- f) Assistant Recording Secretary
- g) District Representatives

Section 2: Caucus Committees

The Caucus shall have the following Committees:

- a) Election Committee
- b) Bylaws Committee
- c) Eugene Mays Award Committee
- d) Walter D. Andrews Award Committee
- e) Scholarship Committee

A. Election Committee

- 1. Members of the Election Committee must be a member in good standing of the Caucus 30 days prior to election.
- 2. The chair of the Election Committee shall be appointed by the Executive Board.
- 3. Members of the Election Committee shall not be a candidate for office or hold an elected position on the Caucus Executive Board.
- 4. Election Committee shall conduct all Caucus nominations.
- B. Bylaws Committee

Consider changes to the Bylaws and make a recommendation to the membership.

- C. Eugene Mays Award Committee Select Award Recipient
- D. Walter D. Andrews Award Committee Select Award Recipient
- E. Scholarship Committee Select Scholarship Recipients

Article XII - Gender

Words in these Bylaws indicating masculine gender shall be deemed also to refer to the feminine gender.

Article XIII - Amendments to CWA Minority Caucus Bylaws

After adoption, these Bylaws may be amended by a majority vote of the members present if the prepared amendment has been submitted in writing thirty (30) days prior to the CWA Minority Caucus meeting or the CWA Convention.

Article XIV - Oaths of Office

"I (give name) hereby accept the office (name of office) with full knowledge of the responsibilities and duties of such office. I promise to faithfully discharge my duties according to these Bylaws. I further promise to give my successor in office all books, funds and records in my possession. I shall at all times endeavor to serve the Caucus and its members to the best of my ability, so help me God."

Amended July 26, 1987: Articles II, VII, VIII

Eugene "Gene" Mays - CWA Pioneer



The story of Gene Mays, the first African-American CWA officer, vividly illustrates the connection between the struggles for civil rights and workers rights. Mays was a coal miner in West Virginia until 1943. After a stint in the Army, he migrated to Buffalo, New York, where he was introduced to the union while working at a Western Electric Wire and Cable plant. He soon joined CWA Local 1162, which together with three other locals, 1192, 1152 and 1170, formed the foundation of CWA in Western New York in the 40's and 50's.

Rising quickly in the union, Mays was elected Local 1162 President in the late 40's and appointed CWA International Staff Rep in 1951. As a leader, he immediately faced major challenges. These were the McCarthy years and unions were not spared from being smeared with the "communist" brush. Shortly after Mays' election as local president, the company tried to decertify the union, making insinuations about the CWA's affiliation with the CIO and Mays' African-American heritage.

Under Mays' leadership, CWA won the battle against decertification in what amounted to a strike for recognition. CWA was certified for Western Electric workers and CWA's combined membership in Western New York grew to 2,000 members. Over the next 10 years, CWA's influence increased as telephone workers were organized, with Mays playing a major role in supervising the efforts in upstate New York. He continued his active involvement when he was appointed Assistant to the Vice President of District One, by Morton Bahr, in 1969. He was still the only black on the staff.

At District One, Mays served as CWA's defense fund agent during the longest strike in the union's history, against New York Tel from July 1971 to February 28, 1972. As defense fund agent, Gene made the decisions of "who got how much and when" says Morton Bahr, retired CWA National President. "He knew he had to make every dollar go to keep that strike going and really take care of the needs. And I know that it took such a tremendous toll out of him. He was never the same after that." Gene Mays died unexpectedly in 1973.
