# Tri County Point Property Owner's Association Minutes, Annual Meeting August 4, 2001

President Rickey Tauzin called the annual Property Owner's Association Meeting to order at 1:00 PM on Saturday, August 4, 2001. A motion was made by JoAnn Strom to skip reading the minutes of the last meeting and seconded by Barbara Hamrick.

The first order of business was the election. Upon signing in to the meeting, all voting members were handed ballots for the election. Completed ballots were placed into a ballot box and President Rickey Tauzin asked for volunteers to count votes. Three members who met the criteria of not being related to anyone nominated for an office were selected to count the votes.

While the votes were being counted, President Rickey Tauzin turned the meeting over to Vice President Will Winnie. Mr. Winnie handed out a financial report and explained the report, as well as answered questions regarding the report. Some of the main points he made were:
