❖ ZONTA Day in Annapolis was Thursday, February 28th 9AM – 3PM

This year we invited other clubs to participate; 4 out of 5 clubs participated with Zonta Club of Mid-Maryland to include Annapolis, Charles County, Howard County and Frederick with 12 plus attendees. We had an introductory conference call January 31st and the partnering clubs participated by bringing items for the continental breakfast and participating in the program (see attached). The District 3 Governor and Area 3 Director, Joanne Gallos and Pat Rosensteele attended, respectively.

Four members represented ZONTA on the floor of the Senate where we received a Citation commemorating our work for women and girls; as well as, congratulations to Zonta International for 100 years of service and advocacy. Senator Joanne Benson was a very gracious sponsor and promised to sponsor ZONTA Day in Annapolis for years to come. We were greeted by Senator Ron Young, Delegate Karen Lewis (SB738 /HB634), Delegate Susie Proctor, staff from various legislators offices to include Caroline Hecker – Legislative Aide of Senator Kathleen Dumais' office (SB 209/HB 122), Delegate Erik Barron and Delegate Ron Watson. We participated in tours of the Government House (the Governor's Mansion) and the State House. The day concluded with lunch, toasts, and conversations at Harry Browne's. ZONTA Day in Annapolis was once again a wonderful event where we learned, told our 'story' and advocated.

The main emphasis of ZONTA Day in Annapolis is to show support of some of the bills we followed. The three bills are as follows (see attachment):

SB209 /HB122 – Protective Orders;

SB688/HB0827 – Juvenile Law, the Child Sex Trafficking Screening and Services Act;

SB 738/HB634 – Labor and Employment.
