Information from code enforcement officers and properties discussed by board members:

- a) Guess (1250 S. Dixie St.) No response since fined. Requests additional fine for tall grass.
- b) Williams (N. Dixie St.) Officer Jimmy Martin reported that the Williams property had no further improvements made since the last meeting. Officer Joy Bennett reported that after a discussion with Kenneth Kidd at Limestone Bank, she was unable to verify that Mr. and Mrs. Williams had obtained financing to replace the roof. The board was in agreement that the owners should be fined.
- c) Froedge (813 E. Side Dr.) Hi grass and dangerous tree abated Board members agreed to close the case.
- d) Lidia Cimins (210 Edwards Av.) Resident (Michael Davenport) to be fined \$200.00 for moving of yard and adjacent lot and trimming of overgrowth.
- e) TSE Investments (22 Chestnut St.) owner to be charged for mowing property two times.
- f) Meadows (2 lots on Church St.) high grass. Notify owner.
- g) Houk (209 Vile St.) city maintenance dept. has mowed grass twice.
- h) Craine (314 N. Butler Rd.) high grass problem being monitored
- i) Dye (201 McFerran St. high grass problem being monitored
