Bud reported that he has talked to Soil and Water about the plan for seeding on the area that was burnt. Will brush hog the small tree sprouts until fall and will then spray them. It will take another year to get things looking good.

#### **ROAD REPORT:**

Eyk reported that he has the site plan ready for the park pavilion, he is working on the mailbox ordinance and will have the Attorney review it.

We have received 3 bids for the 2022 seal coat road projects. Engineers estimate was \$69,400. The bids were Astech: \$76,860, Pearson Brothers \$85,050, and Allied \$67,750. Motion by Bud Stimmler to award the bid contingent on review by Town engineer to Allied, second by Gary Gray. Motion carried. Eyk has asked contractor to give him a 14 day notice before they start the project.
