2015 NASCOE PAC PROMOTION

Details and Rules

- The 2015 NASCOE PAC Promotion period will be April 1, 2015 through 5:00 p.m. (CDT) on August 14, 2015. Version 4-1-15 of the PAC Enrollment/Contribution Increase forms must be completed, signed, dated, and submitted during this timeframe in order to be considered for this promotion.
- 2. Contest participants must be current NASCOE PAC contributors, or enrolled as NASCOE PAC contributors no later than August 14, 2015 at 5:00 p.m. (CDT).
- 3. The NASCOE President, Vice-President, Secretary, Treasurer, Area Executives, National Legislative Chairperson, and Area Legislative Chairpersons are not eligible to compete in this promotional contest.
- 4. PAC Promo Points can be earned in any combination of the following 4 categories:
 - 1. Referring member (can be yourself) is awarded 5 promo points for each new enrollee signed up during the period
 - 2. Referring member (can be yourself) is awarded 10 promo points for each new enrollee with a <u>hire date of Oct. 1, 2014 or later</u>.
 - 3. Referring member (can be yourself) is awarded 1 promo point for each \$1 increase from current contributors. Increases must be submitted during the period. This category will be limited to 10 promo points per current contributor increase.
 - 4. During the period April 1, 2015 through 11:59 p.m. on April 30, 2015, trivia questions will be posted on NASCOE's Facebook page. The trivia questions will be general and cover the subject areas of NASCOE PAC, NASCOE Legislative Issues, and NASCOE History. The questions will appear during random times and dates to ensure fairness of access to all members in all time zones across the country. The first person to visit the NASCOE Facebook page and post the correct answer to the provided question will be awarded 1 PAC Promo Point. Each member will be limited to earning 2 PAC Promo Points in this category. A contest administrator will confirm the answer as soon as possible. You must have a Facebook account, listed in your name, to participate in this category.

- 5. The individual with the highest number of PAC Promo Points will be awarded 10 raffle tickets that will qualify him/her to win a 2015 Chevrolet Cruze or \$10,000 in cash (winner's choice). The individual with the second highest number of PAC Promo Points will be awarded 5 raffle tickets that will qualify him/her to win a 2015 Chevrolet Cruze or \$10,000 in cash (winner's choice). Tickets will be awarded to the contest winners at the Milwaukee, Wisconsin NASCOE Convention, on August 14, 2015, prior to the Convention Banquet. - 6. In the event of a contest tie when final points are tabulated, the National Legislative Chair and PAC Coordinator will determine the method to break the tie.
- 7. Each referring member will be required to maintain a copy of any enrollment/contribution increase forms that are mailed to Donny Green, NASCOE PAC Coordinator, during the promotion period. Each referring member will be responsible for assuring that all enrollment/contribution increase forms completed during this promotion period are delivered to Donny Green.
- 8. At the end of the promotion period, and prior to the prize drawings at noon on August 16th, all new enrollment, contribution increase, and NASCOE Trivia points will be tabulated to determine the winners of the tickets that will be entered for the drawing. The 1st place winner (most PAC Promo Points) will be presented with 10 tickets (value \$200). The 2nd place winner (2nd most PAC Promo Points) will be presented with 5 tickets (value \$100). The 5 raffle tickets awarded to the state with the highest cumulative PAC Promotion Points will be issued with the <u>name of their state association pre-printed on all 5 tickets</u>.
