# August 12, 2019

The Horse Cave City Council met in regular session Monday, August 12, 2019 at 6:00 P.M. at City Hall. #### **NEW BUSINESS**

A. Approve First Reading Ordinance #2019-05: <u>AN ORDINANCE ADOPTING THE REAL AND PERSONAL PROPERTY</u>, WATER CRAFT AND MOTOR VEHICLES TAX RATES FOR THE CALENDAR YEAR 2019.

Motion made by Larry Bunch, seconded by Vickie Rogers to set the 2019 real tax rate at 13.8 cents per \$100, personal property tax rate at 17.26 cents per \$100, motor vehicle/watercraft at 19 cents per \$100; library tax of 5 cents per \$100 will be added to each tax rate.

Motion carried 4-2.

Presentation of the Kentucky Trail Town Certification Hart County/Horse Cave Tourist Director, Sandra Wilson, presented Mayor Curry the official certificate for the certification of the Cave City/Horse Cave Kentucky Trail Town. She thanked all the volunteers, including Mayor Curry, for their work to accomplish the certification.
- C. Approval of the Memorandum of Understanding Mayor Curry, City Attorney Pat Ross, and Chief of Police Heather Childress, addressed the council concerning the Memorandum of Understanding between Caverna Independent School District and the City of Horse Cave in providing Caverna with a sworn officer to act as a School Resource Officer. Motion by Bunch, second by Hatchett.

Approve ordinance #2019-06 AN ORDINANCE TO CREATE AND SELL A FRANCHISE FOR THE PRIVILEGE OF CONSTRUCTING, TRANSPORTING, OPERATING, MAINTAINING, AND DISTRIBUTING NATURAL GAS ALONG AND UNDER THE PUBLIC RIGHT-OF-WAY FOR A TERM OF 20 YEARS AND TO ESTABLISH A BID PROCEDURE FOR THE AWARD OF THE FRANCHISE TO THE SUCCESSFUL BIDDER. Motion by Hatchett, second by Bunch.
