# MINUTES, 2018-2019 BOARD MEETING

SATURDAY, MARCH 24, 2018

Bonnie Sharp, Vice-President, OK WOCP INC called the meeting to order at 8:05 a.m., at the 2018 Tri-State WOCP Show in Norman, Oklahoma.

There were not enough members present to hold the meeting so several of those present went to find other members. At 8:35 a.m. Dorothy Anderson, President, arrived and enough members were located to proceed with the meeting. (NOTE: Article VIII, Meetings, Section 4 states that "A quorum at the annual meeting and special meeting shall be a majority of the registered voting members.")

Janet Crain opened the meeting with a prayer.

Minutes from yesterday's OK WOCP INC Board meeting will be read at September's Board meeting. The Treasurer's report will also be given at the September board meeting.

## **OLD BUSINESS:**

A general discussion resulted in the decision to get the Sharon Scholz's donation of a piece of paint china from Beverly Armstrong. Janet and Bonnie will take care of securing the item.

<u>EDUCATIONAL FUNDS, TRUSTEES IN CHARGE REPORT</u>: Susan Owen for Kathie Southerland stated that \$11,030.50 was in savings and the total amount is \$49,441.28.

A discussion about the OKWOCPINC DUES FOR 2018-2019 confirmed that dues for WOCP are \$40.00, and dues for OKWOCPINC are \$5.00. In addition to the \$45.00 each club will collect their Club dues. The Club dues are to be collected by May 1, 2018, by the club treasurer, and mailed to the new OKWOCPINC Treasurer, Susan Owen.

The State Treasurer, Susan Owen, will ensure that WOCP has received all state dues by May 31, 2018, at the corporate headquarters, which is the World Organization of China Painters Museum in Oklahoma City, Oklahoma.

A discussion was held about the rules for submitting the names of each club's delegates in accordance with the By-Laws. General opinion was that the By-Laws were not being followed and that this should be corrected.

NOTE: Standing Rules states:

"At the first Board meeting of the Annual Year the delegates shall be named by each Club and shall serve for one (1) year as a voting member of each Board meeting."

The Secretary will verify that each Club has done so. This year ends March 24, 2018, on the last day of the Tri-State. See, By Laws, Article XI, Annual Meeting, Section 3.

MOTION: Thelma Ingram moved that the Committee reports be waived and presented at the September Board meeting and that the new business be next on the agenda. Pat Dickerson seconded the motion. (This motion was made since a discussion indicated that no committee reports were ready.) MOTION PASSED.

### **NEW BUSINESS:**

The OK WOCP INC members voted to be a member of the WOCP for the 2018-2019 year.

The nominations from the floor for the Museum Ballot Committee for the 2018-2019 year were Retha Falkenberry, Chairman, Anita Kantowski, and Pat Dickerson. A discussion ensued about the importance of the Museum Ballot Committee having at least one experienced member. It was concluded the new Committee members met the criteria. (Note: Last year's Committee members were Nancy Lepak, Ruthanne Reitz, and Le Yeatts.)

MOTION: Susan Owen moved that Retha Falkenberry (Chairman), Anita Kantowski, and Pat Dickerson be the Museum Ballot Committee for the 2018-2019 year. Anita Kantowski seconded the motion. MOTION PASSED.

Dorothy Anderson announced that the next Board meetings will be at the WOCP Museum on September 22, 2018 and January 19, 2019. Both dates are on a Saturday.

The meeting was adjourned at 8:41 a.m.
