We are pleased you are becoming a part of our shop. We LOVE to support our town & global environment by reusing, recycling, upcycling, and reselling. Thank you!

Here's how it works:

We accept a maximum of 20 very good to excellent items per appointment. If more than 20 items are presented the best 20 will be applied to the consignor's account and the remaining items will be considered a donation to the store for store use. Any items that are dirty, if accepted, will be accepted as a store donation only.

All prices are determined by our experienced staff, giving consideration to current retail sales prices and demand for the product.

Following final inspection and entry into J&J's inventory, an itemized *Received Inventory Report* will be emailed to you. A printed report can also be requested at the shop at any time.

Junk & Java will make a concerted effort to sell all consigned items in an attractive & welcoming selling environment, however the store cannot make any guarantee of items selling. The consignment period for home goods, clothing & jewelry is 90 days.

To keep merchandise fresh & moving, consigned pieces will be marked down in this manner:

1st month - full price

2nd month - 20% off full price

3rd month - 40% off full price

Consignors receive 50% of the final selling price for items selling up to \$249, and 60% of the final selling price on items selling over \$250. If J&J provides pick up service, or has to do cleaning and/or polishing/upgrading of any items then the store receives 60% of the final sales price to offset time & expenses to make item sale presentable.

When your piece(s) sell, you will receive a check in the mail the first week of the month following the sale – **if your monthly total sales equal \$25 or more.** If not, when your total sales balance reaches over \$25 a monthly check will automatically be generated the next month. All balances may be used at any time for in-store purchases.

A \$1.00 processing/postage is deducted each time a check is mailed.

Consignor may not remove consigned items prior to the end of the 90-day contract period for each consignment. At the end of the contract period, consigned items will automatically be donated to area non-profit

If a consignor specifically wants an expired item returned, they must so state in writing at the time of consignment.

. Return items must be picked up within 5 days of the consignment end date. **Please mark your calendar** as we do not have the staff to follow up with each consignor.

Consignors are responsible for finding their unsold items in the store and bringing them to the check-out counter for computer system. After day 95, consigned items become the property of **Junk & Java**, and J&J may sell, donate, or otherwise use or dispose of unretrieved items at their discretion.

Junk & Java will take great care of the articles you consign, however, **merchandise is left at your own risk;** and consignor agrees that J&J is not responsible for loss due to fire, theft, vandalism, natural disaster, in-store damage, or other unusual circumstances.

Junk & Java encourages you to carry home owner's insurance on any of your items of particular value.

By signing this contract below, consignor agrees to all terms stated herein, and certify they fully own, without liens, all items brought in for consignment with all rights to sell items consigned.
