- The contestant will be assigned to the age division according to the contestant's age on September 1, 2022.
  - Adjustments are possible due to numbers per division.
- One crown (3"-6" depending on age group) and sash per division for king/queen.
- A minimum of 5 "Extra" awards will be given based on judges' decisions. Possible examples include eyes, outfit, personality.
- The contestant that sells the most pre-sale tickets will win the title of Hospitality and will receive a special award.
 

*If someone purchases tickets online, place the child's name in the notes section or contestant will need to keep a list of the purchaser(s) name and number of tickets purchased and turn in to us by 4:30 on pageant day.*
- "People's Choice" tickets will be sold during the pageant for \$1 per vote. A special award will be given for the People's Choice award winner.
- Medallion and pumpkin patch pass per contestant for 1 Pumpkin Patch entrance with each paid entry any date we are open to the public.
- Make-up should be age appropriate/natural.
- Dress is Fall Attire- There's always a great variety. Allow your contestant to wear what he/she is most comfortable wearing. Some ideas over the years-bell bottom pants, rompers, ruffle pants, denim, smocked/themed dress, pumpkins, etc. See photos from past pageants on our Facebook page.
- Basic modeling, no glitz.
- Pageant admission is \$5.00 per person (contestants are free). Pageant will be our only event. *Pumpkin Patch events will not be open. Playground will be open.*
- Optional Practice- Thursday, September 29<sup>th</sup> at 5:00 pm
- **Saturday, October 1st PAGEANT at 5:00 pm-** Contestants must be backstage (in our classroom) by 4:00.
