<u>Public Comment:</u> Tim Wrathell is running for Circuit Court Judge and he gave a presentation on what a Circuit Court Judge does. Attached to these minutes are two reports, one from the County Clerk including 2014-2019, and the other from the Michigan Supreme Court Administrative Office. Mr. Wrathell estimated that between 68-69% of all cases in Circuit Court are family law matters which he thinks he can improve in Sanilac County. Mr. Wrathell is the current Bridgehampton Twp. Attorney.

<u>Communications Received</u>: McCarty had a call from a resident who had campaigned for 4 of the board members in 2016. He campaigned for them on the basis that these individuals would clean up the blight in the Twp. and that hasn't happened. He wants to know at what point blight will be taken seriously and something get done?

Hewitt had calls about the Concerned Citizens of Bridgehampton Township Facebook page regarding Doug Sweet running for Sanilac County Drain Commissioner. These individuals wanted the page changed or disbanded. The page is not a Bridgehampton Township Board page and we do not have access as such.
