April 9, 2018

The Horse Cave City Council met in regular session Monday, April 9, 2018 at 6:00 P.M. at City Hall. Present were Mayor Randall Curry, council members Maronda Gibson, Perry Martin, David Lindsey, and Jackie Buckingham.

Citizen's Concerns

- A. A citizen who resides on Woodlawn Ave expressed concern about a unsupervised child riding a motorbike on the sidewalk and Vial St. Mayor Curry asked the police department to be aware and watch for underage riders of mopeds and motorbikes in the area.
- **B.** A resident on Vial Street expressed concern about where visitors to their home were to park and if parking in their yard would be illegal. Mayor Curry explained that parking a vehicle in their yard was not illegal but parking on the sidewalk is a violation. The resident also expressed concern about parking on both sides of the street was a hindrance to traffic flow on the street. Mayor Curry noted that Horse Cave streets are narrow but parking on the streets is not illegal unless it was determined the parking was hindering the flow of emergency vehicles or hindering the view of vehicles at corners.
