- 1. The Department of Education (DepEd) issued DepEd Order No. 3, s. 2016, Hiring Guidelines for Senior high School (SHS) Teaching Positions Effective School Year 2016-2017, which aims to clearly define the application, selection and appointment process of SHS teachers as well as to establish professional standards and evaluation criteria which will ensure that highly competent individuals with the appropriate qualifications and specializations are hired to teach in Senior High Schools.
- 2. Applicants shall register to the Department's on line system at <u>application.deped.gov.ph</u> and submit a written application, supported by the following documentary requirements to the Schools Division Office of Ifugao (SDO) or school head of the SHS where a teacher shortage or vacancy exists:
