**1.      Open Bids for Garbage/Recycling curbside pickup for township.**

The town received sealed bids from Green For Life (GFL), New London Wisconsin; Harter's Fox Valley Disposal, Ringle Wisconsin; Waste Management of Wisconsin, Wisconsin Rapids Wisconsin. The bid tabulation was as follows:

Motion by Phil Durrant, second by Craig Nelson to table the item Ordinance 10/17/22A(2022) Garbage/Recycling Curbside Pickup on Tax Roll until the next Town Board meeting on November 21, 2022 to allow for review of the Harter's Fox Valley Disposal contract by the town attorney. Motion carried on a roll call vote.
