Cool MOVED to compose a letter to the property owner stating that they have until October 22, 2021 to move items out of the District's right-of-way or legal action will be taken. Denny SECONDED the motion. The motion PASSED UNANIMOUSLY.

Miller brought attention to the fact that there is a property owner up by him using an approach through another man's property. The road is not owned or maintained by the Highway District and the approach onto Fairfield Road has been grandfathered in decades ago. The District does not have any legal action to take to help Miller or the current property owner.

Clerk's Report

Floch asked if there was a policy regarding bringing roads up to specifications to adopt them into the District roads. Denny said there was a policy at one time and instructed Floch to look into the meeting minutes to find it.

Floch asked that the Board consider decreasing the permit reimbursement. Discussion was held regarding the amount of time that Willard and Floch invest in the approach permits. Floch asked the Board if they would be willing to spend money on a computer program for right of way maps that would allow her to load deeds and maps. Permission was granted.

Chip seal project was completed with the help of Worley Highway District.

Kenworth truck is at Hoffman Manufacturing getting the box fixed.

Agte Road corner project is completed.

Old Road #6 was reopened. Floch will contact Benewah County for a name.
