 NO ONE UNDER THE AGE OF 16 MAY DRIVE AN ATV. NO riding without proper gear, including helmet goggles and sturdy boots or shoes. NO open toe shoes or sandals.

- NO wheelies, jumps, stunts, bumping or cutting in front of other vehicles or ATVs stop and gunning the or other reckless driving or operation at any time.
- NO driving too fast for the conditions, visibility or experience. Drivers are aware of and must be alert for the possibility of hidden dangers, when riding over unfamiliar terrain.
- NO side hilling. To keep from turning over, you must go directly up and down all hills and embankments. Stay away or use extreme caution on or near, all public roads and vehicular traffic
- NO coasting downhill with transmission in neutral.
- NO operation of the ATV outside designated areas and trails stay on established trails.
- NO operation of the ATV close to any other vehicle or other ATVs.
