Being over the age of 16 know that riding a 4-wheeler or any other all terrain vehicle (ATV), is an activity carrying risks of serious personal injury, property damage, or death. I also know that there are natural, mechanical and environmental conditions and risks which independently or in combination with my activities may cause injury or even death to me or others, as well as property damage. I know that operating ATVs has been the cause of serious injury and death in the past, because of the risks inherent in operation of the vehicle itself as well as where and how they are operated.

Being full aware of these risks, conditions and hazards of the proposed activity as a participant, and in consideration for the enjoyment and experience of being able to rent and operate an **ALL TERRAIN VEHICLE (ATV)**, I **HEREBY AGREE TO WAIVE, RELEASE AND DISCHARGE in advance Richard L. And Tammy J. Johnson sole owners and operators of MONTANA ATV ADVENTURES** from any and all liability, claims for damages for death, personal injury or property damage which I may have or which hereafter accrue to me as a result of my participation in the ATV riding activity arising out of this rental agreement, whether known or unknown at this time, even if that liability may arise out of the negligence or carelessness on the part of persons or entities mentioned above. I agree to accept all responsibility for the risks, conditions and hazards which may occur, whether they be known or unknown, **ARISING FROM ANY ACCIDENT, INJURY OR PROPERTY DAMAGE WHATSOEVER, RELATED TO, RESULTING FROM, OR IN ANY WAY CONNECTED WITH, CUSTOMER'S RENTAL, PARTICIPATION OR OPERATION OF SAID ATV.**

This release contains the entire agreement between parties hereto, shall not be altered except in writing signed by both parties, and shall be considered a contractual agreement and not a mere recital. **CUSTOMER FURTHER STATES THAT HE OR SHE HAS CAREFULLY READ THIS ENTIRE AGREEMENT, SIGNED OF HIS OR HER OWN FREE WILL, AND ON BEHALF OF ANY MINOR CHILD OR CHILDREN WITHIN CUSTOMERS CHARGE, AND IN SO DOING, ACKNOWLEDGES AND AGREES TO ABIDE BY THE FOLLOWING EXPRESS TERMS AND CONDITIONS.**

1. _____ I understand that ATVs are 4 wheeled gasoline powered vehicles which can achieve speeds of over _____ 30 miles per hour, and can suddenly and violently accelerate, turn, overturn, especially on inclined surfaces, and/or lose control, depending on my operation, terrain, and/or weather conditions. **I AM AWARE THAT USE OF ATVs MAY BE HAZARDOUS, AND I HAVE ELECTED TO VOLUNTARILY PARTICIPATE IN THIS ACTIVITY WITH FULL KNOWLEDGE, ACCEPTANCE AND ASSUMPTION OF ANY AND ALL RISKS OF PERSONAL INJURY OR DEATH. I acknowledge that the ATV must at all times be operated in a reasonable, safe and prudent manner. I acknowledge that failure to observe and abide by the following may unreasonably or unnecessarily endanger life, limb or property, INCLUDING BUT NOT LIMITED TO THE FOLLOWING:**

- NO ONE UNDER THE AGE OF 16 MAY DRIVE AN ATV.
- NO riding without proper gear, including helmet goggles and sturdy boots or shoes. NO open toe shoes or sandals.
- NO wheelies, jumps, stunts, bumping or cutting in front of other vehicles or ATVs stop and gunning the or other reckless driving or operation at any time.
- NO driving too fast for the conditions, visibility or experience. Drivers are aware of and must be alert for the possibility of hidden dangers, when riding over unfamiliar terrain.
- NO side hilling. To keep from turning over, you must go directly up and down all hills and embankments. Stay away _____ from, or use extreme caution on or near, all public roads and vehicular traffic
- NO coasting downhill with transmission in neutral.
- NO operation of the ATV outside designated areas and trails – **stay on established trails.**
- NO operation of the ATV close to any other vehicle or other ATVs.
- NO passing other ATVs in your group – **stay in your assigned positions at all times.**

NOTE: Violation of any of the above may result in immediate termination of ATV rental *without* ANY refund.

2. _____ I warrant that both MYSELF and MY minor children (where applicable) must act responsibly and in a careful manner as mature adults in operating the ATV and state that I or my minor children have no medical condition(s) or disabilities incompatible with the safe operation of an ATV. I acknowledge that NO ONE under the age of 16 may drive an ATV.

3. _____ I ACKNOWLEDGE THAT I AM NOT PERMITTED TO OPERATE ANY ATV WHILE UNDER THE INFLUENCE OF, OR IN ANY WAY IMPAIRED BY ANY DRUG (LEGAL OR ILLEGAL) OR ALCOHOL. BY INITIALING THIS STATEMENT, I HEREBY WARRANT THAT ***I AM NOT UNDER THE INFLUENCE, OR IN ANY WAY IMPAIRED BY, ANY DRUG AND/OR ALCOHOL.***

4. _____ I agree not to operate the ATV outside designated areas.

5. _____ I agree to pay repair costs to any damage to the ATV covered by this rental agreement, other than ordinary wear and tear. I further agree to hold harmless and indemnify Richard L. And Tammy J. Johnson sole owners and operators of MONTANA ATV ADVENTURES for any and all loss or damages, including theft, to MYSELF or other persons, objects or property including, but not limited to, any eyewear (prescription or non-prescription eyeglasses, contact lenses, sunglasses, etc), cash, jewelry, electronic equipment, including all cell phones and cameras or other personal property, caused by or arising out of MY use or operation of the rented ATV.

6. _____ I acknowledge that before operating any ATV of MONTANA ATV ADVENTURES, I MUST DEMONSTRATE SAFE DRIVING SKILLS ON THE Safety Course, or during the first part of the ride which is on a level dirt road, and have had the opportunity to ask questions. IF YOU CANNOT PASS THIS DEMONSTRATION, WE WILL REFUND YOUR MONIES TO YOU AND TAKE YOU BACK TO YOUR VEHICLE. THIS RULE IS ENFORCED FOR THE SAFETY OF ALL PARTICIPANTS

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation of this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Richard L. Johnson sole owners and operators of MONTANA ATV ADVENTURES herein.
