A RESOLUTION ACCEPTING THE PROPOSAL OF ACTIVE EXCAVATING & WRECKING, INC. FOR CLEANING, ROOT CUTTING AND TELEVISING APPROXIMATELY 150 FEET OF 8-INCH PVC DRAIN TILE

Be it resolved by the president and the board of trustees of the Village of Lily Lake, Kane County, Illinois that:

- 1. The village accepts the proposal of Active Excavating & Wrecking, Inc. to clean, root cut and televise approximately 150 feet of 8-inch PVC drain tile for \$2800, in accordance with its proposal, a copy of which is on file in the clerk's office, with the following modifications:
 - (a) The second note is replaced in its entirety with the following language:

"Note: As a representative of the Village of Lily Lake, I authorize you to do the work as specified. This proposal must be signed, dated and faxed or mailed back to our office before work can be scheduled. The non-prevailing party, as determined by the court, shall pay the reasonable attorney's fees, costs and expenses incurred by the prevailing party in the enforcement of this contract."

(b) The following language is added:

"The Standard Terms and Conditions for Contracts with the Village of Lily Lake are incorporated into this proposal and made a part hereof. In the event of a conflict between any term of this proposal and the Standard Terms, the Standard Terms will prevail."

- 2. If it is determined that the drain tile is broken, Active shall repair the tile for an additional amount not to exceed \$1400.
- 3. The clerk shall send a copy of this resolution to the contractor along with the signed copy of the proposal.

Estimate to hydro jet and root cut existing 8" PVC under drain from manhole in southeast corner to where it daylights, approximately 150' to the southeast. Televise 8" PVC to determine if pipe is broken (possibly under boulder ditch check) and repair if necessary, we quote: \$4,200.00

Alternate Estimate: If 8" PVC pipe only needs to be jetted, root cut and televised and no repairs are needed, we quote: \$2,800.00

We exclude the following:
