#### ORDINANCE NO. 2020-02

### AN ORDINANCE AMENDING VILLAGE CODE

(Chapter 7—Public Safety, Subchapter 4—Nuisances)

BEITORDAINED by the President and the Board of Trustees of the Village of Lily Lake, Kane County, Illinois, that the Village Code, as amended, be further amended as follows:

# § 1. Amending Village Code

Chapter 7—Public Safety, Subchapter 4—Nuisances, § 765, subsections (a),(d),and (l) as amended, are further amended as set for the low and the following subsection (m) is added:

### § 765. Noise

The following are prohibited—

(a) Construction. To make, or permit to be made, noise from construction, repairor remodeling that can be heard at a distance of 100 feet or more from its source, between the hours of 9:00 PM and 6:00 AM Monday through Friday and between the hours of 9:00 PM and 8:00 AM on Saturdays, Sundays and legal holidays.

(d) Lawn equipment and tools. To operate a power lawn mower, or other power lawn or landscaping equipment, or other power tools between the hours of 9:00 PM and 7:00 AM.

\* \* \* \* \*

(l) Exemptions. This section does not apply to noise generated by agricultural equipment on land zoned A-Agriculture and actually used for agricultural purposes. This section does not apply to work performed for or on behalf of a public body.

\* \* \* \* \*

(m) Enforcement. A complainant alleging a violation of this section must make a formal complaint to the Kane County Sheriff's Office. Any citation issued will be processed by the Kane County Administrative Adjudication Officer through the county's Administrative Code Hearing Department.

## § 2. Repealer

Any ordinance or any provision of any ordinance in conflict with the provisions of this ordinance is, to the extent of such conflict, repealed.

### § 3. Effective Date

This ordinance is fully effective from and after its passage, approval and publication as provided by law.
