RELEASE, INDEMNIFICATION, COVID-19 WAIVER, AND AUTHORIZATION TO USE LIKENESS  
("Release")

**READ THIS DOCUMENT CAREFULLY**

In consideration of Participant's participation, whether as a student, instructor, volunteer, camp guest, or otherwise, in a camp operated by Pittsburgh Elite Officiating Camps, LLC ("PEOC"), Participant, intending to be legally bound, for himself and his heirs, personal representatives, executors, administrators and assigns (collectively, "Participant Parties"), forever releases, remises, and discharges any and all rights, demands, claims and causes of suit or action, known or unknown, whether arising now or in the future, that he has now or may have in the future against PEOC and any of its members, owners, administrators, instructors, independent contractors, any property owners associated with or providing resources to PEOC, and any other participating sponsors and any officers, employees and agents of such parties (collectively, "PEOC Parties"), for any and all injuries, including death and property damage in any manner arising in any way out of his participation in camps operated by PEOC. Participant attests and verifies that he has full knowledge of the risks involved in officiating ice hockey and engaging in physical activity, that he assumes those risks and that he will, without limitation, assume and pay any medical and emergency expenses in the event of an accident, injury, illness or other incapacity, regardless of whether he has authorized such expenses. PEOC strongly recommends that Participant consult his physician before engaging in any physically strenuous and/or dangerous activities such as participating in a PEOC camp.

Participant further agrees, on behalf of himself and his Participant Parties, to indemnify and hold harmless the PEOC Parties with respect to any and all claims (including any claims brought by Participant or by any of his personal representatives, successors or assigns), losses, liabilities or damage (including, without limitation, attorneys' fees) that arise out of or relate in any way to Participant's act(s) or omission(s) in connection with his participation in PEOC.

THIS RELEASE INCLUDES A WAIVER OF ANY AND ALL CLAIMS ARISING OUT OF OR RELATING IN ANY WAY TO COVID-19. Participation in a camp operated by PEOC, in both on-ice and off-ice settings, will inherently increase Participant's risk of exposure to Covid-19. Participant agrees to abide by all state, local, and federal mandates relating to Covid-19, as well as any measures implemented by a PEOC Party to curtail the spread of Covid-19. If you are showing signs of, or have been exposed to, Covid-19, you agree to refrain from attending a PEOC camp, and to notify PEOC immediately of the same. **PARTICIPATE IN PEOC CAMPS AT YOUR OWN RISK. PEOC CANNOT PROTECT YOU FROM CONTRACTING COVID-19.**

Participant hereby authorizes PEOC to use his voice, name, and likeness in connection with any and all promotional and educational materials, in any medium whatsoever, created by PEOC Parties, and Participant shall not be entitled to compensation for the same.

Participant or his guardian if under the age of 18 verifies that he has carefully read this Release, knows the contents of the Release and signs the Release of his own free will. Wherever used herein, a masculine pronoun shall be construed to include the feminine.
