The door knob we ordered from Hilltop Lumber is the wrong one. We'll need to exchange it for the correct one, a 6-pin knob.

Painting and Staining the Hall

It took Kevin about 2 days to stain the hall. Hirshfields had a sprayer that we rented for \$25/day to apply it.

Tree Trimming Update

We got quotes from Joe's Cutting Edge - \$24,000 and Carr's Tree Service - \$42,000. To trim Centennial Lane, Pioneer Park, Moe Hall Road, Walstad Road, Century Road, Bayview, Eternity Point Road, Norlana Lane, Ironwood Lane, Timber Lane, and Tall Timbers.
