

The 2019 Fellowship Brunch




Dr. Herbert Exum, a native of Tarboro and a 1967 graduate of the former W.A. Pattillo High School, was the keynote speaker. Dr. Exum received an undergraduate degree in psychology from Federal City University in Washington, D.C., and completed his master's and doctorate degrees in counseling and student personnel psychology at the University of Minnesota in Minneapolis, Minn. He is an author and professor emeritus. He has an extensive career nationally and internationally.

Dr. Exum humored the audience with some of his memories of waiting to attend school, former teachers when he was a student at Pattillo and shared highlights of the year he attended school in New Jersey. He said it was a relief when he returned to Tarboro and graduated from Pattillo. The main emphasis of his speech was the importance of "Self-Care," constructing a "Self-Care Plan," conducting a "Self Assessment" and finally, making "Self-Care" non-negotiable.

PUBLICATION Committee. Continued its oversight programs for all official publications and served as the approving authority for all posts to Facebook, webpage and media in the public domain. Continued to generate articles related to various facets of the association or alumni in local newspapers/magazines. Other vital functions are developing association forms and certificates. SCHOLARSHIP Committee. Mounted a successful scholarship fundraising event. Selected eight seniors to receive the W. A. Pattillo, George C. Matthewson and Harrison Family Scholarships. Recommended the induction of one individual into the Hall of Fame in

the category of Band and Chorus. Is tasked with reviewing the selection procedures for the Distinguished Graduate Chapter.

MEMBERSHIP Committee. Continued to purge and restructure its databases. Continues to provide a monogrammed pen to new members. The committee continued to serve as the unit for direct mailings to the population of the database.



In Lecture-Recital was Dr. Leroy Bynum Jr., an acclaimed lyric tenor. Bynum, a native of Tarboro, currently resides in Portland, Oregon, where he serves as dean of the College of the Arts and professor of voice and opera at Portland State University.

He attended the former W.A. Pattillo High School and graduated from Tarboro Senior High School in 1972. Dr. Bynum holds performance degrees from the University of Georgia, the University of South Florida and UNC-Chapel Hill. He has also earned several performance certificates nationally and internationally.

Dr. Bynum melodiously made the audience forget about the cold and wet conditions outside with his superb performance of “My Soul is a Witness: Spirit and Spirituality” in the Songs of America’s Slaves. His performance was a perfect way to recognize and celebrate Black History Month.
